Northern States Power Company, doing business as Xcel Energy, submits this Small Generator Facility Interconnection Report in accordance with ARSD § 20:10:36:63 which requires:

“.....The public utility shall annually provide to the commission a list of each small generator facility that is interconnected to the public utility's EDS during the calendar year and shall include the size of the facility, the amount paid by the small generator to the public utility for interconnection, the date of the application, and the date the interconnection was completed. The report for the calendar year is due the following March 1.”
