South Dakota Public Utilities Commission

Mission Statement:

The South Dakota Public Utilities Commission will serve and protect South Dakota's consumers by ensuring safe, reliable and high quality utility services. The commission will exercise its authority and influence to ensure that residential and business consumers have access to utility services at fair and reasonable rates. The commission will be proactive and solutions-oriented in striving to maximize consumer utility value and education while working to enhance the economic and environmental well-being for citizens of South Dakota.

2018 Summary:

The commission has territory, complaint and quality of service authority regarding all telecommunications companies operating within South Dakota. The commission retains its switched access rate making authority for all telecommunications companies providing local service, including small, independent and cooperative companies.

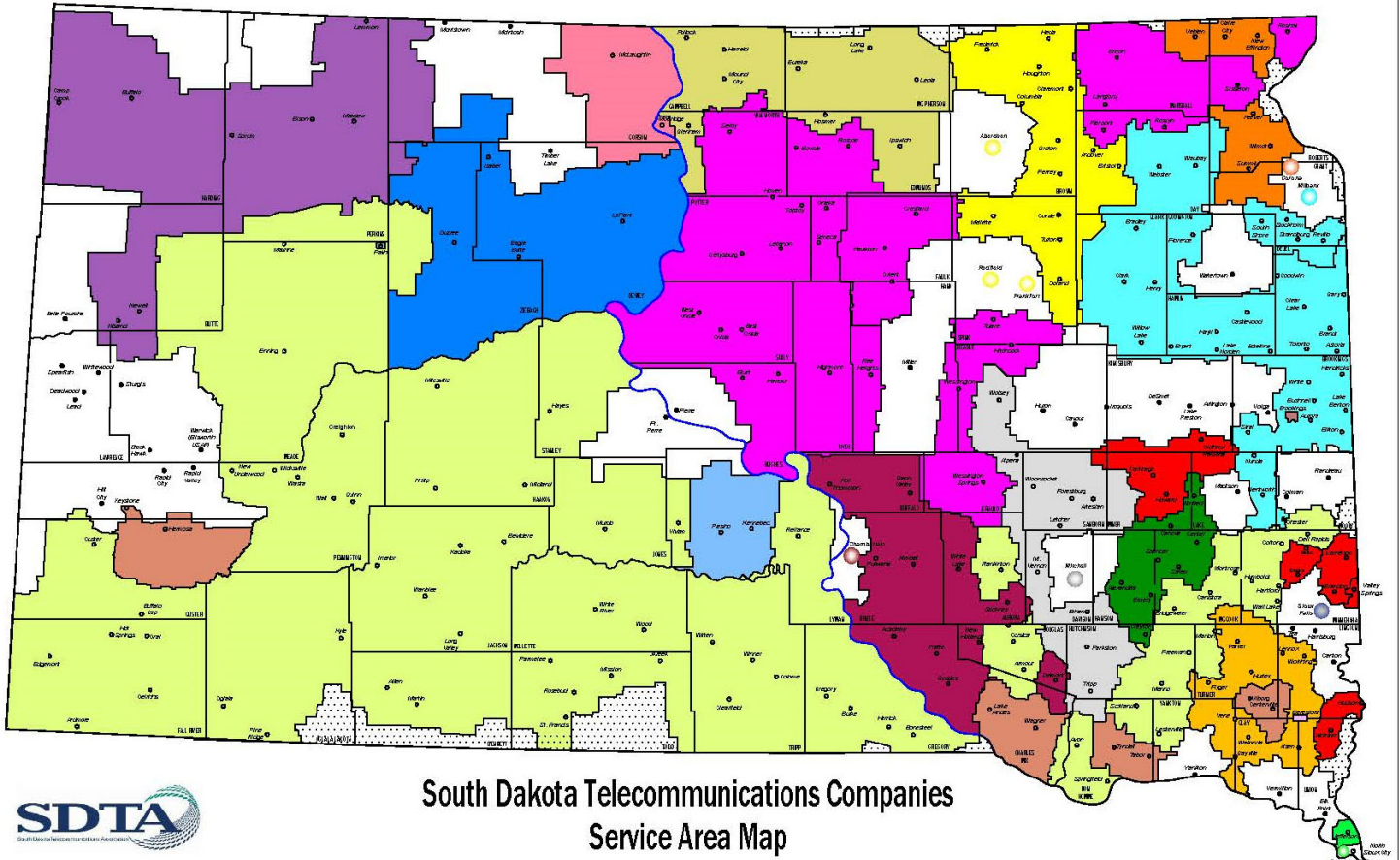
In 2018, 61 telecommunications dockets were filed with the commission. In addition to these dockets, the commission received 160 informational filings. No formal complaint dockets were filed.

The commission's Consumer Affairs staff assisted consumers with 186 telecommunications issues and 119 wireless concerns.

Lifeline and Link-Up and Enhanced Lifeline and Enhanced Link-Up programs provide qualifying South Dakotans access to affordable telephone service. In 2018, South Dakota telecommunications companies reported a total of 3,130 Lifeline customers and 769 Enhanced Lifeline customers. More information on Lifeline and Enhanced Lifeline trends can be found on page 8.

As of the end of 2018, thirty-seven companies were designated as Eligible Telecommunications Carriers (ETCs) by the commission. Additionally, one telecommunications carrier is designated as an ETC by the Federal Communications Commission. These telecommunication companies are eligible to receive High Cost Support and/or Low Income Support from the Federal Universal Service Fund administered through the Universal Service Administrative Company (USAC). In 2018, USAC distributed more than \$108 million in High Cost Support and over \$1.9 million in Lifeline and Link-Up monies to these South Dakota companies. More information on the USAC distribution trends can be found on pages 11 and 12.

Please note that for this year's annual report, companies were asked to report VoIP lines separately from telephone lines. This may cause the appearance of a decline in the number of telephone lines for each company.

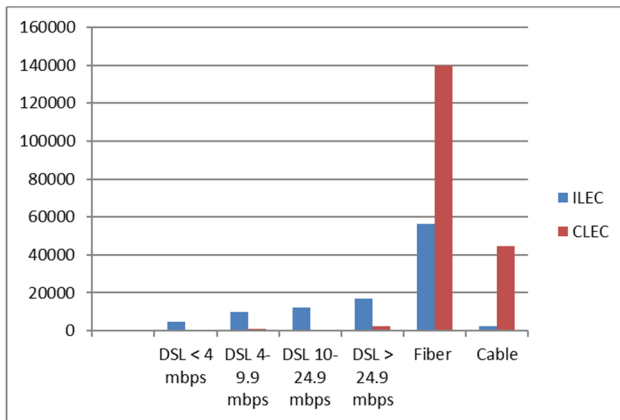

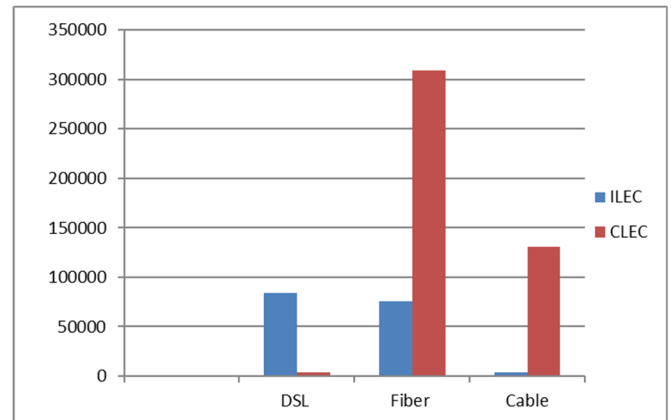
