IN THE MATTER OF THE FILING BY NORTHWESTERN CORPORATION DBA NORTHWESTERN ENERGY FOR APPROVAL OF ITS SOUTH DAKOTA DEMAND SIDE MANAGEMENT PLAN ORDER APPROVING DEMAND SIDE MANAGEMENT PLAN AND ENERGY EFFICIENCY ADJUSTMENT RATES

On July 6, 2015, NorthWestern Corporation, dba NorthWestern Energy (NorthWestern), filed with the South Dakota Public Utilities Commission (Commission) a report on the first year of activity under NorthWestern's two-year South Dakota Demand Side Management (SDDSM) plan. The report outlines the SDDSM plan's Year 1 activities and expenses; provides program and budget updates for the Year 2 plan proposed for July 1, 2015, through June 30, 2016; and requests changes to NorthWestern's tariffs to true up the Energy Efficiency Adjustment rates based upon Year 1 results and the Year 2 proposed budget. The requested tariff revisions are as follows:

At its regularly scheduled meeting on September 15, 2015, the Commission considered this matter. Following a presentation by NorthWestern, Staff recommended that NorthWestern's South Dakota Demand Side Management Plan be approved with the following conditions:

- 1. The Commission allow for a Year 2 spending flexibility up to 30% over the approved Year 2 budget;
- 2. The Commission cap the Year 2 electric and gas performance incentive based on the lesser of Year 2 actual spending or Year 2 approved budget; and
- 3. The Commission approve NorthWestern's proposed electric and gas Energy Efficiency Adjustment rates for Year 2 and tariff sheets, with an effective date of October 1, 2015.

After discussing the matter, the Commission voted unanimously to approve the Energy Efficiency Adjustment rates and tariff sheets with an effective date of October 1, 2015. With Commissioner Nelson dissenting, the Commission voted to approve NorthWestern's Year 1 SDDSM report, NorthWestern's proposed SDDSM plan's Year 2 program changes, and NorthWestern's SDDSM plan's Year 2 proposed budget.

The Commission finds it has jurisdiction in this matter pursuant to SDCL 49-34A, specifically, 49-34A-6, 49-34A-8, 49-34A-8.2, 49-34A-10, and 49-34A-11. Further, the Commission finds that NorthWestern's request for approval of its energy efficiency plan, with the conditions recommended by Staff, is just and reasonable and shall be approved. It is therefore

ORDERED, that NorthWestern's Energy Efficiency Adjustment Rates and tariff sheets set forth above are hereby approved with an effective date of October 1, 2015. It is further

ORDERED, that the performance incentive shall be based on the lesser of the approved Year 2 SDDSM plan budget or Year 2 actual expenses. It is further

ORDERED, that a spending flexibility up to 30% over the Year 2 proposed budget is hereby approved.
