The Commissioners and Staff are available for discussion on the topics contained in this report.



2000 Highlights and activities

BACKGROUND

The South Dakota Public Utilities Commission consists of three elected at-large Commissioners each serving staggered, 6-year terms. In addition, the Commission has 24 staff members. The Commission is authorized by statute and regulates the rates and service quality of investor-owned electric, natural gas, and telephone utilities and has territorial jurisdiction over all retail electric utilities, including cooperatives, independents and municipals; it registers interstate motor carriers; it licenses and inspects grain elevators and grain dealers; it operates the natural gas pipeline safety program; and it has administrative responsibility for the state's one-call notification program which regulates excavation activities. The Commission also handles consumer complaints involving the service quality of all the referenced industries.

ADMINISTRATIVE

Commissioner Laska Schoenfelder was re-elected to her third term as a South Dakota Public Utilities Commissioner.

ELECTRICITY

No electric industry restructuring legislation has been introduced and there is currently little impetus for electric industry restructuring in South Dakota. A study by the University of South Dakota, sponsored by the state's rural electric cooperatives, found that electric industry restructuring was not in the interest of most customers in the state. There are few industrial customers in the state and even these have not pushed aggressively for electric industry restructuring. The Commission continues to use its authority to approve contracts with deviations to allow pricing that is both flexible and reflective of a market-oriented approach.

The Commission in the past year approved interactive rates between utilities and customers that allow customers to share benefits of marketed power made available when the customer forgoes consumption. The Commission continues to encourage inventive and incentive service and pricing strategies by energy suppliers which inject market-type discipline and are expected to benefit both company and customers.

The Commission has been responsible for regulating electric rates since 1975. The Commission has the authority to set retail rates, territorial boundaries and customer service regulations such as credit and disconnection policies, and these regulations are applied to investor-owned utility companies. The PUC also regulates rural electric cooperatives, but it has no jurisdiction over the rates charged by cooperative and municipal utilities.

South Dakota is ranked fourth in the nation for its wind generating potential. A number of developers are securing easements for wind development and East River Power Cooperative is looking into the possibility of forming a wind power cooperative that would retain ownership of wind energy from generation to marketing.

South Dakota is closely monitoring the Regional Transmission Organization (RTO) activity. Recent developments and proposals for both planned and potential RTO's could have significant impacts on the delivered cost of South Dakota's power supply. We have additional concerns about Federal Energy Regulatory Commission (FERC)-adopted ratemaking principles which could cause dramatic increases in transmission rates. We are in a "wait-and-see" posture, but are prepared to press our case if necessary.

NATURAL GAS

Through the summer and fall of 2000, the Commission was involved in settlement negotiations with Northern Natural Gas pipeline, various utilities and natural gas producers located in the state of Kansas regarding the issue of refunds to be paid by Kansas producers concerning overcharges stemming from prices paid to those producers during the 1980s. A settlement was reached and submitted to the Federal Energy Regulatory Commission on November 20, 2000. Comments were submitted to expedite the FERC's approval so that refunds could help offset current high gas prices. At this time refunds are hoped to be passed through to end users in March of 2001.

On September 14, 2000, Commissioner Schoenfelder and staff, along with MidAmerican representatives and local legislators, attended a public meeting in Yankton regarding the current and expected high gas prices. Separately, the Commission contacted each natural gas utility and requested data on expected gas availability during the upcoming heating season and certain cost information. Commission Staff has and continues to monitor and review natural gas costs being passed through to end users as well as addressing an increased public comment regarding high gas prices. The Commission Staff has also been interacting with the regulated gas utilities regarding financial assistance available to low income end users and continues to do so.

ONE-CALL NOTIFICATION

South Dakota One-Call is a mandatory statewide one-call notification system established to inform all South Dakota underground facility operators of intended excavation. In its sixth year of operation, the South Dakota One Call Notification Board has contracted with One Call Systems Inc. of Pittsburgh, Pennsylvania, as its systems operator. The One Call Notification Board functions as an eleven-member board whose members are appointed by the Governor and, by statute, represent various utility and contracting industries.

PIPELINE SAFETY PROGRAM

The purpose of this program is to protect South Dakota citizens from avoidable safety mishaps involving the transmission and distribution of natural gas and propane. This program has jurisdiction of over 3,775 miles of transmission and distribution pipelines that serve over 154,600 South Dakota customers. South



operators, five municipal natural gas system operators, two natural gas master meter system operators, four propane system operators, and four intrastate pipeline operators.

This program performs a semi-annual inspection schedule. Over each two-year period, more than 65 safety features are inspected. The safety features subject to inspection in each year of the two-year schedule are further divided into semi-annual inspections. Efficiency is achieved for smaller operators by limiting their inspections to a single, annual inspection. This program routinely conducts unscheduled inspections of new construction and investigates safety infractions. There was one incident reported during the 2000 calendar year.

TELECOMMUNICATIONS

On March 22, 2000, the Circuit Court overturned the Commission's denial of ETC (eligible telecommunications company) designation for GCC License Corporation (Western Wireless). The Commission appealed the decision to the South Dakota Supreme Court and a decision is pending.

U S WEST and Qwest Merger - The Commission had no jurisdiction over the merger. However, prior to the merger, Qwest Communications paid a \$50,000 fine to the state and a \$1000 payment to each of the consumers it slammed.

Slamming and Cramming remain the top consumer complaints and the Commission streamlined its complaint processing procedure by eliminating its probable cause determination through rulemaking. The Commission entered into a settlement agreement with Western Telecom following numerous slamming complaints against the company. The company paid a fine of \$2,500 to the state and a \$1,000 payment to each of the consumers it slammed.

South Dakota does not have a state universal service fund (USF) program though it is expected that the state's independent and cooperative telephone companies will introduce enabling legislation this year.

Service quality complaints decreased by half compared to 1999.

The Commission participated in the Section 706 field hearings and completed a survey of the deployment of advanced services in the state.

Qwest has deployed DSL service only in its two largest exchanges, Sioux Falls and Rapid City. Held orders for this service are rising as Qwest appears unable to keep up with demand. The state's cooperative and independent telephone companies are deploying DSL services in many of their small exchanges.

The Commission did not join but is monitoring the Qwest multi-state Section 271 process. Qwest filed its Statement of Generally Accepted Terms (SGAT) on November 22, 2000. Action on this filing is pending.

Qwest Corporation, South Dakota, sold one of its more rural exchanges to a local cooperative telephone company. Three exchanges were also sold in which the central offices were located in adjoining states. Citizens has filed to acquire these exchanges and a decision is pending before the Commission.

The Commission approved 53 new Certificates of Authority bringing the number of certified companies to 280 in the state.

ANNUAL REPORT FOR YEAR

TRANSPORTATION/WAREHOUSE

The transportation/warehouse division licensed and monitored 349 grain dealers and warehouses consisting of 242 Grain Storage Facilities, 32 Non-storage Facilities, 42 Truck Grain Dealers and 33 Grain Brokers. It also approved licenses and required bonding or insurance coverage for 24 General Storage Facilities. In addition, the division registered insurance and issued permits to 1,135 single state SSRS Federal Highway Authority (previously known as ICC) truckers and 2,766 Exempt commodity haulers.

The division has one part-time and two full-time inspectors who annually perform 300-400 general and special inspections on the grain warehouses and grain dealers. The inspectors also perform grain checkoff inspections for the SD Wheat Commission and the SD Soybean Council. These inspectors additionally work with the Motor Carrier Division of the SD Highway Patrol to examine truckers passing through the ports and weigh stations for proper authority and grain license truck decals.

There appears to be a trend developing involving moving away from stored grain toward Voluntary Credit Sales (VCS) contracts. By doing this elevator facilities are able to free up grain for shipping, allowing the facilities to handle larger quantities of grain. This poses a risk for producers as the VCS contracts are not covered by the grain dealer or grain warehouse bonds. Therefore, the Commission is closely monitoring the financial health of all grain dealers within the state making sure producers are doing business with strong companies that will not default on these contracts.

Another trend concerning Voluntary Credit Sales contracts is the move from basic VCS contracts (Delayed Price, Deferred Payment) to more elaborate hybrid contracts. Due to this the contracts are becoming more complex and harder to understand. Additionally, the grain warehouse industry continues to change as evidenced by the 17 facilities that changed hands in 2000.

Consumer affairs divisIon

Division Responsibilities:

- Investigate consumer complaints,
- Negotiate settlements between consumers and utility companies,
- Consumer outreach and education,
- Advise Commission on consumer issues,
- Assist consumers when addressing the Commission, and
- Develop recommendations for change in rules.

A total of 2270 complaints were handled by the division in the year 2000. Of those complaints, 1880 involved telecommunications, 233 involved electricity, and 119 involved natural gas. The chief issues were:

Telecommunications

- ◆ 377 unauthorized switching of telecommunications services
- ♦ 285 billing errors
- 178 raising rates without notices
- 99 delayed installation of service
- 97 unauthorized billing for products or services
- ♦ 79 poor service

Electricity

- ♦ 104 disconnections
- ♦ 24 billing
- ♦ 20 outages

Natural Gas

- ♦ 37 high gas prices
- ♦ 24 disconnections
- ◆ 16 billing

Through the efforts of the PUC, South Dakota consumers were able to recover \$275,000. In addition, fines and penalties of over \$52,500 assessed by the PUC were added to the state treasury.

2000 Court action

IOWA UTILITIES BOARD, ET AL. v. FEDERAL COMMUNICATIONS COMMISSION, No. 96-3321 and Consolidated Cases

The Commission, along with numerous other state commissions and telecommunications companies, filed an appeal with the Eighth Circuit Court of Appeals of the Federal Communications Commission's (FCC) rules interpreting the federal Telecommunications Act of 1996 (federal Act). The Commission, along with three other state commissions, also filed for a stay of the FCC's pricing rules. The Eighth Circuit granted the stay on October 15, 1996. The state commissions' issue was whether the FCC exceeded its jurisdictional authority when it promulgated rules regarding the methodologies to be used in the pricing of network elements and services necessary to provide competitive local exchange service. The state commissions contended that the federal Act left the pricing of network elements and services to the state commissions, not the FCC. Briefs on the merits were filed and oral argument was held before the Eighth Circuit on January 17, 1997. On July 18, 1997, the Eighth Circuit ruled that the FCC exceeded its jurisdictional authority when it promulgated the pricing rules. The decision was appealed to the U.S. Supreme Court. On January 25, 1999, the Supreme Court reversed the Eighth Circuit on a number of issues including the issue of whether the FCC exceeded its jurisdictional authority by issuing rules regarding pricing methodologies. The case was remanded back to the Eighth Circuit and the Eighth Circuit issued its decision on remand. The Supreme Court recently decided to review that decision also and the case is back at the Supreme Court.

IN THE MATTER OF THE ESTABLISHMENT OF SWITCHED ACCESS RATES FOR USWEST COMMUNICATIONS, INC

On June 24, 1996, U S WEST filed for approval by the Commission of its 1995 switched access cost study and the resulting switched access rates. The matter was the subject of two administrative hearings, one in October 1996 and another in September 1997. It has been appealed to the Sixth Judicial Circuit Court twice and remanded twice. Upon the last remand, the Commission entered its decision and that was appealed by U S WEST. The parties stipulated to submitting the matter for a third time to the Court upon written briefs. The Circuit Court affirmed the Commission's decision. U S WEST appealed to the S.D. Supreme Court. The Supreme Court also affirmed the Commission's decision's decision.

Court action

<u>CLAY-UNION ELECTRIC CORPORATION v. THE CITY OF VERMILLION AND</u> <u>S.D. PUBLIC UTILITIES COMMISSION</u>

On October 20, 1997, the city of Vermillion filed an Application for Determination of Purchase Price of Electric Facilities in Annexed Areas. The Commission issued an Order to Show Cause on February 24, 1998. Clay-Union sought an Order to Stay Proceedings and an Action for Declaratory Judgment in the First Judicial Circuit. The stay was denied and the parties agreed to an indefinite continuance to allow them to proceed with an orderly exchange of service territory and property. The parties filed a Stipulation and Agreement with the Commission on June 30, 1998. On August 5, 1998, the Commission entered its Order Approving Stipulation and Closing Docket. Clay-Union alleged in its Action for Declaratory Judgment that the statutory provisions of SDCL 49-34A are unconstitutional. The issues were briefed by the parties. On March 1, 2000, the Court issued its decision, finding that Clay-Union does not have a property interest in the service territories. However, the Court found that the poles and wire are property and requested further briefing from the parties on how the acquisition of poles and wires should be handled. The parties subsequently agreed to withdraw from the Court's consideration the issue relating to poles and wires. Clay-Union filed a Motion to Withdraw on January 16, 2001. Judgment was filed with the circuit court on January 24, 2001.

<u>U S WEST COMMUNICATIONS, INC. v. JAMES A. BURG, PAM NELSON,</u> <u>LASKA SCHOENFELDER, COMMISSIONERS OF THE PUBLIC UTILITIES</u> <u>COMMISSION AND AT&T COMMUNICATIONS OF THE MIDWEST, INC.</u>

U S WEST filed a complaint against the Commissioners and AT&T in federal district court on April 6, 1999. U S WEST appealed a number of issues the Commission had decided in its AT&T/U S WEST arbitration decision. In that decision, the Commission ruled on the issues AT&T and U S WEST had been unable to resolve regarding their interconnection agreement. The Commission filed a Motion to Dismiss, based primarily on jurisdictional grounds, which was denied. The parties then briefed the issues raised by U S WEST. A few days before the parties were scheduled for oral argument before the federal district court, U S WEST voluntarily dismissed the action.

Court action

IN THE MATTER OF THE FILING BY GCC LICENSE CORPORATION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

GCC License Corporation (GCC) appealed the Commission's decision denying GCC designation as an eligible telecommunications carrier (ETC) for the entire state of South Dakota. The Commission found that since GCC is not actually offering or providing a universal service offering through a fixed wireless system, it must deny GCC's application for ETC status throughout the state because section 214(e)(2) requires an ETC to be meeting the requirements for ETC designation before a Commission may designate an additional requesting carrier as an ETC. The Commission further found that it could not base its decision on whether to grant ETC status to GCC based on GCC's current mobile cellular service because: (1) it is not sufficiently comparable to its proposed fixed wireless system; and (2) GCC failed to show that its current mobile cellular system is able to offer all the services that are supported by federal universal support mechanisms throughout the state. Finally, the Commission found that even if it could grant a carrier ETC status based on intentions to serve, GCC failed to show that its proposed fixed wireless system could be offered to customers throughout South Dakota immediately upon being granted ETC status. The circuit court reversed the Commission's decision. The Commission, SDITC, and U S WEST appealed to the Supreme Court. The Supreme Court affirmed the circuit court and remanded back to the Commission for a decision on whether it is in the public interest to designate GCC as an ETC for areas served by rural telephone companies.

IN THE MATTER OF THE ONE-TIME SPECIAL UNDERGROUND ASSESSMENT BY NORTHERN STATES POWER COMPANY IN SIOUX FALLS, SOUTH DAKOTA

On March 31, 2000, Northern States Power Company (NSP) appealed the Commission's decision ordering NSP to refund an assessment it had charged to all of its Sioux Falls customers. The assessment was to cover the costs of NSP's underground placement of a 13,800 volt three-phase feeder line. The Commission found NSP had failed to show that the two and one-half block underground placement of the line benefited all of its Sioux Falls customers. The circuit court reversed the Commission's decision. The Commission appealed the reversal to the Supreme Court. The case is currently pending before the Supreme Court.

NANCY MANNING AND ELIZABETH FREDERICK v. U S WEST COMMUNICATIONS, INC. AND MCLEOD TELECOMMUNICATIONS SERVICES

On May 5, 2000, Nancy Manning and Elizabeth Frederick appealed the Commission's decision finding McLeod Telecommunications Services, Inc. liable for some damages relating to the provision of telephone service to the law offices of Ms. Manning and Ms. Frederick. Numerous issues were raised in the appeal. On September 13, 2000, the Commission received notice that the appeal had been dismissed.

Court action

<u>UNITED STATES TELECOM ASSOCIATION v. FEDERAL COMMUNICATIONS</u> <u>COMMISSION AND UNITED STATES OF AMERICA</u>

The United States Telecom Association (USTA) appealed a Federal Communications Commission (FCC) declaratory ruling to the Court of Appeals for the District of Columbia Circuit. *See* Declaratory Ruling, *In the Matter of Federal-State Joint Board on Universal Service; Western Wireless Corporation Petition for Preemption of an Order of the South Dakota Public Utilities Commission*, CC Docket No. 96-45, FCC 00-248 (rel. Aug. 10, 2000) (the "Declaratory Ruling"). In that decision, the FCC provided guidance regarding whether section 214(e)(1) of the Communications Act of 1934, as amended, (the "Act"), requires a common carrier to provide supported services throughout a service area prior to being designated an eligible telecommunications carrier. The FCC held that state public utilities commissions may not interpret section 214(e)(1) of the Act to require a common carrier to furnish supported services throughout a service area prior to being designated as an eligible telecommunications carrier (ETC). USTA's Petition for Review alleged that the Declaratory Ruling is (1) arbitrary, capricious, an abuse of discretion, or otherwise not in accordance with law; (2) in excess of statutory jurisdiction, authority, or limitations, or short of statutory right; (3) without observance of procedure required by law; and (4) unsupported by substantial evidence. The Commission filed to intervene and has raised numerous issues.

2000 Legislative action

SB 160 An Act to provide for a fund to assist in the delivery of advanced telecommunications services.

This bill required providers of intrastate telecommunications services to pay into a fund that would be used to support the provisioning of advanced telecommunications services. The bill was tabled by the Senate State Affairs Committee.

SB 162 An Act to provide for the creation of a no solicitation calls list for persons wishing not to receive unsolicited telephone calls, to create a telephone solicitation account, and to establish certain fees and civil penalties.

This legislation allowed telephone subscribers to list their telephone numbers on a register. Once listed on the register, a telephone solicitor was prohibited from making unsolicited telephone calls to that number. The Senate Commerce Committee deferred the legislation to the 36th legislative day.

HB 1131 An Act to authorize the Public Utilities Commission to establish procedures and fees for the location of certain utilities across railroad rights-of-way.

This bill authorized the Commission to establish fees to be paid to the owners of railroad rights- of-way when overhead or underground facilities are placed in the rights-of-way. The House State Affairs Committee deferred this bill to the 36th legislative day.

HB 1211 An Act to revise the date at which certain telecommunications companies may begin certain promotions for local exchange service.

This bill changed the effective date by which certain telecommunications companies may begin promotions for local exchange service in certain areas. The effective date was changed from December 31, 2000, to December 31, 2001. The bill was signed into law.

HB 1232 An Act to establish a system for measuring and billing a renewable energy source provided by a customer-generator.

This legislation allowed the use of net metering for electrical energy generated by a facility that uses as its fuel a nondepleting source of energy. If any unused energy credits remained at the end of the year, the electric utility would pay the customer-generator at the utility's avoided cost. The bill was tabled by the House Commerce Committee.
