
The Commissioners and Staff are available for discussion on the topics contained in this report.

The Gross Receipts Tax Fund Revenues fund entirely and exclusively the Commission's Fixed Utility Division.

2002 Highlights and activities

BACKGROUND

The South Dakota Public Utilities Commission consists of three elected at-large Commissioners each serving staggered, 6-year terms. In addition, the Commission has 24 staff members. The Commission is authorized by statute and regulates the rates and service quality of investorowned electric, natural gas, and telephone utilities and has territorial jurisdiction over all retail electric utilities, including cooperatives, independents and municipals; it registers interstate motor carriers; it licenses and inspects grain elevators and grain dealers; it operates the natural gas pipeline safety program; and it has administrative responsibility for the state's onecall notification program which regulates excavation activities. The Commission also handles consumer complaints involving the service quality of all the referenced industries.

On December 30, 2002, Montana-Dakota Utilities Co. (MDU) filed an application with the PUC for an increase in the investment in facilities used to provide service to its Black Hills system customers. It had been approximately 7 years since MDU filed the last rate increase filing. The Commission suspended the proposed effective date of the increase and has until June 30, 2003, to issue a decision before suspension authority expires and rates take effect. Staff testimony is due April 23, 2003, and a hearing in this matter is scheduled to commence May 7, 2003. NG02-011.

TELECOMMUNICATIONS

On July 27, 2001, Qwest Corporation filed a Petition for Initiation of Cost Docket to Determine Prices for Unbundled Network Elements in Qwest's Statement of Generally Available Terms (SGAT). On September 14, 2001, intervention was granted to AT&T Communications of the Midwest, Inc. and to Midcontinent Communications. On July 2, 2002, Qwest filed updated cost studies, and a technical conference between Qwest and Commission Staff was held in December of 2002. Additional cost studies and testimony were filed by Qwest in January, 2003. Staff testimony is due June 16, 2003, and a hearing in this matter is scheduled to commence September 16, 2003. TC01-098.

On October 25, 2001, Qwest Corporation filed with the SDPUC a Petition for Recommendation that the Federal Communications Commission Grant Qwest Entry into the In-Region InterLATA Market Under Section 271 of the Telecommunications Act of 1996. Intervention was granted to Black Hills FiberCom, LLC, Midcontinent Communications, and AT&T Communications of the Midwest, Inc. on December 5, 2001. A Procedural Schedule was issued December 18, 2001, setting January 18, 2002, as the date that Staff and Intervenors identify disputed issues (except for issues relating to the final OSS report which had not yet been issued); a prehearing conference was held on February 7, 2002; Staff and Intervenors' testimony was due March 18, 2002; Qwest had until April 2, 2002 to file rebuttal testimony; and the hearing was scheduled for the week of April 22, 2002. At its February 20, 2003 meeting, the Commission agreed to recommend to the FCC that this filing was in the public interest. TC01-165.

PROPOSALS FOR THE 78TH SESSION OF THE SOUTH DAKOTA LEGISLATURE

Three areas of interest to the Commission will receive priority treatment during the 78th legislative session. First, the Commission will seek passage of legislation establishing a Do Not Call register in South Dakota. Second, the Commission will be asking the legislature to support the repeal of the "Gag Law" as to its application to the Commission. Third, the Commission will work with the legislature and industry in seeking an equitable solution to "capping" the agency's Gross Receipts Tax Fund.

CONSUMER AFFAIRS

During calendar year 2002, the Commission received 1,918 consumer complaint contacts which included:

Telecommunication complaints = 1,540

Natural Gas complaints = 91

Electricity complaints = 228

The Commission resolved 1,807 complaints during calendar year 2002.

During calendar year 2002, the Commission saw a decrease in complaints from calendar year 2001. There were 2,965 complaints during calendar year 2001. The Commission recovered \$183,771.08 for consumers in 2002.

Regulated Utility Companies

The Commission has territory, complaint and quality of service authority over all natural gas, electric and telecommunication utilities operating within South Dakota. Certain utilities are exempt from the Commission's rate regulation. They include municipal, rural electric cooperatives and small, independent and cooperative telephone companies. The Commission retains its switched access rate making authority for all telecommunications companies providing local service, including small, independent and cooperative companies.

On July 1, 1999, the rates for Qwest Corporation's residential and local exchange service were capped by the South Dakota Legislature at the rates previously set by the Commission and then in effect.
