#### ABOUT THE SOUTH DAKOTA PUBLIC UTILITIES COMMISSION

#### **Utility regulation**

The PUC ensures utility companies in South Dakota provide safe, reliable service at fair and reasonable rates. The commission regulates investor-owned electric, natural gas and telephone utilities. It plays a more limited regulatory role with respect to wireless telecommunications companies and cooperative, independent and municipal utilities.

#### Other responsibilities

The PUC helps resolve disputes between customers and their utilities, operates the South Dakota Do Not Call Registry and administers the state's One Call notification center (call before you dig). The commission also operates the natural gas pipeline safety program and licenses and inspects state public storage, state public grain warehouses, and grain dealers.

#### Advocacy and education

The commission advocates for smart energy and telecommunications policy at state and federal levels and works hard to educate consumers about ways to save energy and money. The PUC acts as a resource to landowners, communities and developers for both renewable energy development and for the build-out of our state's wireless networks.

#### Information superhighway

The commission's main Web site, www.puc.sd.gov, has a wealth of information from utility company phone numbers to a comprehensive docket system. Live audio Web casts of nearly all commission proceedings, including commission meetings and hearings, are accessible from the Web site and are archived for later reference. Use statistics show that on average, 72 unique users viewed 1,060 pages of the PUC site each day from January 2008 through December 2008. Compared to 2007 use, the Web site was accessed by 30 percent more users who viewed 15 percent more pages of information. More than 96 percent of the users are from outside state government's computer network, indicating the Web site is a valuable resource to utilities, attorneys, consultants and citizens interested in the work of the PUC.

#### The PUC also maintains four other Web sites:

- www.SDDoNotCall.com: An overview of how consumers can add their personal phone
  numbers to the national registry to decrease the amount of telemarketing calls they
  receive. The site also describes how telemarketing companies doing business in South
  Dakota need to comply with applicable statutes and rules.
- www.SDEnergySmart.com: A guide for South Dakota consumers to become more energy efficient. The site includes links to the state's utility providers that are partners in the South Dakota Energy Smart initiative.
- www.SDOneCall.com: The site includes an electronic ticketing system for excavators
  and others who use the Call Before You Dig notification service and an index of
  complaints, among other important information. The PUC maintains the site for the One
  Call Board.
- www.SDWind.com: A major component of this site is information from the Wind Resource Assessment Network, a network of 11 stations that record wind speed and other vital. Data collected by WRAN is interpreted by researchers at SDSU.

#### **COMMISSIONERS**

South Dakotans elect their three Public Utilities Commissioners to staggered, six-year terms.



Commissioner Dustin "Dusty" Johnson. Elected 2004. Term ends 2010. When Dusty Johnson was elected to the Public Utilities Commission, he became the youngest utilities commissioner in the nation. He is currently serving as the commission's chairman, a post he also held in 2007. Since joining the commission, he has played a role in developing renewable energy resources, expanding broadband and wireless phone capabilities, keeping utility rates low and protecting consumers.

Dusty currently serves on the board of directors and the electricity committee of the National Association of Regulatory Utility Commissioners and on the Western Interconnection Regional Advisory Board. Prior to joining the PUC, Dusty was Gov. Mike Rounds' senior policy advisor for economic development, energy, corrections and transportation issues. He has also worked for local governments in the Kansas City area and as a Truman Fellow for the U.S. Department of Agriculture in Washington, D.C.

Dusty has a bachelor's degree in political science from the University of South Dakota, a master's degree in public administration from the University of Kansas, and in 1998 was named a Harry S. Truman Scholar. He is on the board of directors for the W.O. Farber Fund and for Abbott House (a residential treatment center for girls), and served on the Attorney General's Open Government Task Force and as an adjunct professor at Dakota Wesleyan University.



**Commissioner Steve Kolbeck.** *Elected 2006. Term ends 2012.* Steve Kolbeck is the current vice chairman of the commission, a role he is continuing from 2008.

He is a member of the National Association of Regulatory Utility Commissioners, serving on the association's Committee on Telecommunications. He has been appointed to the Federal-State Joint Board on Jurisdictional Separations and NARUC's Ad Hoc Committee on

National Wireless Consumer Protection Standards. Steve is also a leader in industry organizations, holding offices as treasurer of the Mid-America Regulatory Conference and chairman of the Regional Oversight Committee.

Steve has extensive experience in the telecommunications industry, having held positions with Northern Telecom (now Nortel Networks), AT&T, South Dakota Network (now SDN Communications), and Alliance Communications.

Prior to joining the commission, Steve served as a Brandon, S.D., city councilman for three years. Steve attended Northern State University and holds an Associate of Applied Science degree in telecommunications from Mitchell Technical Institute. He is a native of Salem, S.D.



Commissioner Gary Hanson. Elected 2002 and 2008. Term ends 2014. Gary Hanson has served as the PUC's chairman in 2005 and 2008. Gary represents South Dakota on the National Association of Regulatory Utility Commissioner's Committee on Energy Resources and the Environment, and he represents NARUC Commissioners on the steering committee of the National Wind Coordinating Collaborative. He is chairman of the South Dakota Underground Pipeline Task Force and past treasurer of the Organization of MISO States.

Gary's service to the state also includes three terms in the South Dakota Senate, where he was chairman of the Senate Government Audit and Operations Committee and vice chairman of the Senate Taxation Committee.

A native of Sioux Falls, Gary was twice elected as Mayor of that city and oversaw the multiple departmental operations of more than 1,200 employees. Prior to that, he was Sioux Falls' Utilities Commissioner for six years and was responsible for the development and day-to-day activities for three municipal utilities.

As a regional and industry leader, Gary has been involved as a co-founder, past president and chairman of the Lewis and Clark Regional Water System; past chairman of the South Dakota Public Assurance Alliance; and past president of the Sioux Falls Board of Realtors. Gary owned small businesses for 16 years and is a licensed real estate auctioneer, appraiser and broker.

#### **STAFF**

The PUC's 27 staff members perform a variety of duties on behalf of the citizens of South Dakota and in support of the commissioners.

As **executive director**, **Patricia Van Gerpen** serves as the chief administration officer of the PUC. She is responsible for the overall management of the PUC staff and is the direct liaison between the commissioners and staff on all issues.

**Heather Forney**, **deputy executive director**, manages the commission's fiscal activities by preparing budgets and handling accounting, payroll and purchasing duties. She also schedules commission meetings and hearings.

Advising the commissioners are **John Smith**, **general counsel**; **Greg Rislov**, **commission advisor**; and **Rolayne Ailts Wiest**, **commission attorney**. The attorneys also represent the commission itself in state and federal courts and before federal regulatory agencies. Rolayne's additional specialties are advising about federal regulation and state legislative matters. Greg provides policy and technical consultation and research support regarding major regulatory issues.

Administrative staff members Demaris Axthelm, Anissa Grambihler and Delaine Kolbo perform a variety of support services including handling incoming phone calls and mail, greeting guests, coordinating mailings, maintaining the docket section of the PUC Web site, making travel arrangements, and disseminating information about weekly filings and meeting agendas to the public.

**Brian Rounds** and **Tim Binder** are **analysts** who primarily concentrate on **emerging technologies** such as wind energy, wireless telecommunications and energy efficiency efforts. They engage in outreach activities to consumers, industry representatives and students and provide docket analysis as assigned.

Analysts in the Fixed Utilities Division are responsible for investigating, analyzing, evaluating and presenting testimony regarding issues and policies related to the electric, natural gas and telecommunications industries as regulated by the commission. Terri LaBrie Baker, Dave Jacobson, Bob Knadle and Jon Thurber use their skills to focus on quality of service, financial and rate matters as they work to understand and evaluate complex rate structures, earning requirements, and technical issues of various utility organizations.

Karen Cremer and Kara Semmler are staff attorneys. They interpret state statutes and legal considerations for each of their assigned dockets and represent the staff in proceedings before the commission. They work closely with the analysts as they develop recommendations for policy, rate and enforcement matters. They coordinate the presentation of the staff's case and cross-examine other parties who submit testimony.

The **Pipeline Safety Division** is staffed by engineers **Nathan Solem** and **Stacy Splittstoesser** with Nathan handling additional duties as acting pipeline safety program manager. The PUC administers this program on behalf of the U.S. Department of Transportation. Nathan and Stacy inspect and investigate intrastate natural gas pipelines, master meters and propane systems to ensure the public is provided safe and dependable gas service. The two also analyze utility dockets as assigned.

**Jim Mehlhaff** is the director of the **Warehouse Division** that works to protect property rights of customers and safeguard payments to grain producers. **Judy Page** assists with the issuance of warehouse and grain dealer licenses. **Justin Blais** and **Ryan Riedy** conduct grain warehouse and grain dealer inspections and investigations. The warehouse staff also performs check-off audits for various grain commissions and councils.

The **Consumer Affairs Division** works with customers to answer questions and resolve complaints about the rates and services of regulated utilities. Manager **Deb Gregg** and representatives **Vicky Burns** and **Jason Schuchard** act as liaisons between consumers and utility companies in resolving these issues. This division also coordinates the PUC's presence at home shows and fairs and makes presentations as requested.

**Leah Mohr** and **Tina Douglas** work on **communications** projects for the commission that include news releases, publications, and education and awareness efforts. They are also responsible for the coordination of community meetings and conferences, and the content management of the agency's Web sites.

#### **2008 YEAR IN REVIEW**

2008 Leadership: Gary Hanson, Chairman; Steve Kolbeck, Vice Chairman; Dusty Johnson, Commissioner

#### **ELECTRIC AND NATURAL GAS**

- Received affirmation from the South Dakota 6th Circuit Court of the PUC's decision to allow for the construction of the Big Stone II power plant near Milbank.
- Hosted four workshops which resulted in a statewide best practices model for connecting small generating facilities to the electric grid. The model was submitted to the commission for consideration in a separate rulemaking docket. The workshops were part of the PUC's docket to implement the Public Utility Regulatory Policies Act provisions of the Energy Policy Act of 2005.
- Commissioner Dusty Johnson addressed the Minnesota Public Utilities Commission as it
  considered whether to approve proposed transmission facilities from the Big Stone II
  power plant near Milbank, S.D., into their state. Johnson's comments emphasized the
  region's need for additional baseload generation and the environmental advantage of
  the new plant's pollution controls. The construction of these transmission facilities
  would allow significant new wind-generated electricity to be transported as well.
- Commissioner Gary Hanson testified about electric transmission issues before the U.S. Senate Committee on Energy and Natural Resources. His comments focused on challenges and regional solutions to developing transmission for renewable electricity resources.
- Approved applications by East River Electric Power Cooperative for the construction of two separate 115 kV transmission lines. The first, a 13-mile line that will run through portions of Brown and Day counties, will provide service to a pumping station in Day County for the TransCanada Keystone Pipeline and be available for future electric loads. The second, a 9.5-mile line through portions of Lincoln and Turner counties, will provide service to the Poet Biorefining Ethanol Plant near Chancellor as well as handle future electric loads.
- Approved a request from the South Dakota Oilseed Processors for NorthWestern Energy to provide service for the large electric load required at the company's new soybean crush facility east of Miller.
- Approved an application by Xcel Energy to allow the company a transmission cost recovery tariff related to transmission facilities that will allow additional capacity for wind generation from the Buffalo Ridge area and for the company's load center in and around Sioux Falls. This is the first such tariff that has come before the commission in accordance with legislation passed in 2006.
- Began a process to develop electric service territory maps using Geospatial Information Systems (GIS) technology.

Approved an application by Xcel Energy for the company's environmental measures
cost recovery tariff. The action allows the company to collect from ratepayers eligible
costs associated with new pollution controls for its coal-fired generating plant in
Stillwater, Minn. This is the first such tariff that has come before the commission
following legislation passed in 2007.

#### **TELECOMMUNICATIONS**

Achieved a resolution of the multiyear local number portability (LNP) dispute between
the rural local exchange carriers (LECs) and the wireless carriers enabling the expansion
of intermodal LNP in South Dakota on terms mutually acceptable to the rural LECs and
the wireless companies.

#### **ENERGY EFFICIENCY**

- Conducted public education and outreach on energy efficiency through visits to three elementary schools in Rapid City and Madison, meeting with more than 375 students in second, third and fourth grades.
- Delivered presentations and met with members of the agriculture industry about ways to make their operations more energy efficient at seminars in Freeman, Lemmon, Gettysburg, Mission, Hot Springs and Philip. Met with consumers at Energy Efficiency Awareness Day in Rapid City.
- Achieved goal of motivating 4,000 people to pledge to change bulbs in their homes to energy-saving models like compact fluorescent lights. In total, the pledgers agreed to change nearly 22,000 bulbs to save energy.
- Approved Otter Tail Power Company's energy efficiency programs that provide cash rebates and credits to commercial, industrial and residential customers that install energy-efficient equipment and devices to help them reduce their energy use.

#### **CONSUMER ASSISTANCE**

- Conducted a statewide awareness campaign to encourage South Dakotans to prepare for the winter heating season by weatherizing their homes, making other energy-efficient home improvements and taking advantage of a balanced billing option offered by their utility. A series of news releases received extensive media coverage throughout the state.
- Assisted consumers on more than 2,500 occasions with issues and complaints about electric, natural gas, telecommunications, energy efficiency and other utility-related topics.
- Conducted personal outreach at farm and home shows in Watertown, Sioux Falls and Rapid City; fairs in Aberdeen, Sioux Falls and Huron; and AARP financial management seminars in Sioux Falls and Rapid City. Commissioners and staff answered consumer questions about utility issues and promoted the Do Not Call Registry, Lifeline and Link-Up telephone assistance programs and energy efficiency.

- Coordinated a statewide awareness effort to increase the use of Lifeline and Link-Up
  telephone assistance programs among qualified South Dakotans. Created and
  distributed print materials, broadcast a television commercial and discussed the
  programs at outreach events. More than 200 consumers contacted the PUC to request
  applications for the program. Additional inquiries were received by the Department of
  Social Services and the participating telephone companies.
- Affected a 24 percent increase in the number of South Dakota telephone numbers on the Do Not Call Registry with a statewide promotional campaign that included a television commercial, print materials and outreach efforts. More than 440 enrollments were handled by commissioners and staff at outreach events such as home shows and fairs. At the end of 2008, there were 474,511 South Dakota telephone numbers on the Do Not Call Registry.

#### PIPELINE SITING AND INSPECTION

- Approved a siting permit, with 57 conditions, for the TransCanada Keystone Pipeline project. The 220-mile crude oil pipeline is being constructed across the South Dakota counties of Marshall, Day, Clark, Beadle, Kingsbury, Miner, Hanson, McCook, Hutchinson and Yankton. The project also includes four pump stations to be located in Day, Beadle, Miner and Hutchinson counties.
- Opened an investigation into the occurrence of a fire at the town border station near
  Pierre on the Montana-Dakota Utilities Co. natural gas distribution system. Negotiated
  an agreement among staff and interveners Montana-Dakota Utilities Co. and South
  Dakota Interstate Pipeline for a process that successfully prevented incident
  reoccurrence during recovery of a pipeline inspection gauge (PIG).
- Completed an investigation into the natural gas explosion which occurred in a
  residential neighborhood in Mitchell in March 2007 on a distribution pipeline owned
  and operated by NorthWestern Energy. Investigation included arranging for the testing
  and examination of a portion of the pipe that leaked. A report was issued to analyze
  whether violations of pipeline regulations occurred in connection with the incident.

#### **WIRELESS**

- Received petitions from residents of Hamill, Tuthill, Norris, Reva, Hoven and Hot Springs calling for improved wireless service in and around their communities. Petitions contained a collective 1,689 signatures. Petitions are forwarded to wireless companies and the requests are discussed with company officials.
- Continued the advancement of the PUC Wireless Initiative by coordinating with wireless telecommunications providers and community leaders for the construction of 48 new wireless sites in and around Aberdeen, Alexandria, Angostura Reservoir, Bath, Beresford, Billsburg, Burke, Caputa, Castle Rock, Chester, Dell Rapids, Draper, Florence, Fort Pierre, Fort Thompson, Freeman, Harrisburg, Henry, Herreid, Hot Springs, Humboldt, Kadoka, Keystone, Lower Brule, Midland, Milbank, Mission Hill, Mount Coolidge, Newell, Onida, Pierre, Rapid City, Rosholt, Seneca, Sioux Falls, Spearfish, Sturgis, Volga, Volin, Wall Lake and Wessington Springs.

- Encouraged wireless companies as they launched wireless broadband services with Evolution Data Optimized (EVDO) technology at more than three dozen existing sites in and around Akaska, Angostura Reservoir, Armour, Bowdle, Buffalo, Burke, Dakota Dunes, Edgemont, Eureka, Fairfax, Gettysburg, Henry, Herreid, Ipswich, Kadoka, Lake Andes, Lemmon, Midland, Mission Hill, Mobridge, Mud Butte, Onida, Parkston, Pickstown, Pierre, Platte, Rapid City, Roscoe, Scotland, Selby, Seneca, Sioux Falls, Wall Lake and other locations along Interstate 90 and portions of the Black Hills.
- Participated with Lower Brule Sioux Tribe officials and Alltel Wireless representatives in a ribbon cutting event to dedicate the company's new wireless tower in Lower Brule.
- Directed the South Dakota Tower Work Group in the completion of model ordinances
  for the siting of wireless communication towers and wind energy systems. The
  documents were drafted to be easily adapted by local governments to meet their needs
  to encourage development without sacrificing responsibility and integrity. Model
  ordinances were distributed to more than 370 planning and zoning agencies throughout
  the state. As a result, the PUC has helped half dozen zoning administrators draft new
  ordinances with similar requests expected.

#### **LEADERSHIP**

- Commissioner Dusty Johnson was selected to serve on the board of directors of the National Association of Regulatory Utility Commissioners.
- Commissioner Steve Kolbeck was named to the Federal-State Joint Board on Jurisdictional Separations established by the Federal Communications Commission. The board determines how costs among inter- and intrastate telecommunications companies should be distributed.
- Commissioner Steve Kolbeck was appointed to NARUC's Ad Hoc Committee on National Wireless Consumer Protection Standards.
- Commissioner Steve Kolbeck began his one-year term as president of the Regional Oversight Committee, an organization of state regulatory commissions from 14 Midwest and Western states that monitors and shares information about the telecommunications industry.
- Commissioner Gary Hanson was appointed chairman of the South Dakota
   Underground Pipeline Task Force. The seven-member task force presented its findings
   to Gov. Mike Rounds in December. Among the recommendations are for South Dakota
   One Call to develop a database identifying high profile underground facilities and to
   require mandatory damage reporting. The task force further recommended the PUC
   look into acquiring the liquids program for intrastate pipelines from the U.S.
   Department of Transportation.
- Commissioner Gary Hanson was re-elected to PUC. He began serving his second six-year term in January 2009.

#### **WIND ENERGY**

- Discussed wind energy with middle and high school science classes in Faith, Brookings and Mitchell.
- Announced the selection of eight schools to participate in the South Dakota Wind for Schools program. A 1.8-kilowatt wind turbine will be installed at Sanborn Central in Forestburg, Douglas in Box Elder, Memorial Middle School in Sioux Falls and schools in Faith, Selby, Aberdeen, Elkton and Stanley County. Together with specific wind energy science curriculum, the turbines will provide hands-on alternative energy education to students.
- In its role as state facilitator for the South Dakota Wind for Schools program, the PUC received commitments from local utilities to provide in-kind and financial support for the program. Utility partners include Central Electric Cooperative, Black Hills Power, Missouri River Energy Services/City of Faith Electric Department, Montana-Dakota Utilities Co., NorthWestern Energy, Otter Tail Power Co., West Central Electric Cooperative and Xcel Energy. In November, the state facilitator's duties were transitioned from the PUC to an individual from Pierre working at the direction of the National Renewable Energy Laboratory, the coordinating agency for the national Wind for Schools program.
- Secured financial support for the South Dakota Wind for Schools program from wind energy developers Babcock & Brown, Iberdrola Renewables and FPL Energy (now known as NextEra Energy Resources). Together, the developers contributed \$30,000 for construction costs of installing the educational turbines at the schools.
- Hosted three Wind Energy Briefing sessions for legislators. The well-attended forums in Rapid City, Sioux Falls and Pierre featured an overview of wind energy development in South Dakota, discussion about energy policy issues and the opportunity for legislators to ask pre-session questions.
- Discussed wind energy with middle and high school science classes in Faith, Brookings and Mitchell.
- Contributed to the development of the "South Dakota Landowner's Wind Power
  Development Handbook," a guide that describes the wind development process for
  those considering placing a wind energy system on their property. The publication was
  coordinated by the South Dakota Energy Infrastructure Authority. The South Dakota
  Attorney General's Office also contributed information for the booklet.

#### **WAREHOUSE**

 Researched incidents and disseminated a warning via statewide media alerting grain buyers of a regional grain contracting scheme. The scheme involved a person entering into delivery contracts under a fictitious name with no intentions of producing or delivering grain to fulfill the obligations. The sellers in question are believed to not be legitimate and are not from South Dakota.

- Issued 302 warehouse and grain dealer licenses and performed 378 grain warehouse and grain dealer inspections. The PUC also performed 69 check-off audits for various grain commissions and councils.
- Instituted a vigorous monitoring process upon the announcement of VeraSun Energy's
  reorganization. Maintained daily communications with company representatives and
  performed additional on-site facility inspections in VeraSun's trade areas with an
  emphasis on monitoring grain buyers' financial ability to pay grain producers and
  suppliers. Posted frequently asked questions and other updates about VeraSun on the
  PUC Web site.

#### **LEGISLATION**

- Developed and successfully supported legislation to protect customers served by electric and natural gas utilities from risks associated with the ownership and operation of affiliated companies. The intent of this ring-fencing legislation is to separate the public utility's operations from those of a nonutility affiliated company or subsidiary.
- Developed legislation to clarify procedures for suspending a rate or practice that has been proposed by a gas or electric provider and for refunding any proposed increase put into effect by a utility prior to a PUC decision regarding the rate increase.
- Shepherded the passage of legislation that eliminated the PUC's regulation of public storage warehouses.
- Developed, with industry representatives, a package of bills related to grain buyers and grain warehouses. The changes addressed the definition of a grain buyer, bonding of grain, and license fees for public grain warehouses.
- Requested and supported passage of legislation to revise requirements regarding the
  notification of landowners who live near a proposed energy facility. In part, the new law
  states the applicant must notify landowners within one-half mile of all proposed
  facilities that require a siting permit.

#### TOP PRIORITIES

The South Dakota Public Utilities Commission focuses on the state's ratepayers and utility producers, managing its responsibility with the long-term public interest in mind. Accordingly, the priorities listed on the following pages are those the commission examines to evaluate the fulfillment of its responsibility.

#### **Electric and Natural Gas**

The commission looks after the welfare of South Dakotans as related to electric and natural gas issues. Actions taken by the commission strive to ensure reliable service and reasonable rates from investor-owned utilities as well as fair service territory boundaries for all utilities. The commission follows guidelines prescribed by South Dakota law when siting energy conversion and transmission facilities and serves as an objective resource on renewable energy issues. The components of this priority affect South Dakotans in terms of reliability and cost of their electric and natural gas services.

The PUC uses number of ways to measure the agency's effectiveness at handling these issues.

#### Rates

Reviewing electric and natural gas rates from around the state, region and nation offers perspective to evaluate the financial impact South Dakota ratepayers experience compared to residents of other states.

Measurement, Average Residential Electric Rate, October 2008

- South Dakota: 9.01 cents/kWh
- West North Central Region (Iowa, Kansas, Minnesota, Missouri, Nebraska, North Dakota, South Dakota): 9.06 cents kWh
- United States: 11.86 cents kWh

Measurement, Average Natural Gas Rate, 2007

- South Dakota: \$10.49/thousand cubic feet
- West North Central Region (Iowa, Kansas, Minnesota, Missouri, Nebraska, North Dakota, South Dakota): \$11.44/thousand cubic feet
- United States: \$13.06/thousand cubic feet

#### Completed Electric and Natural Gas Dockets

The number of electric and natural gas dockets completed each year reveals the agency's ability to manage its duties and workload. The measurement also alerts agency officials if the process by which dockets are assigned, analyzed and acted upon by staff and commissioners is appropriate. The commission seeks to attain an annual completion goal of 85 percent.

Measurement, 2008

Uncompleted dockets: 9

Percentage completed: 80%

#### Overturned Electric and Natural Gas Dockets

Parties that file requests or applications with the Public Utilities Commission and intervenors to those dockets have the right to challenge the commission's decision in circuit court. The number of dockets that are overturned by judicial order is an assessment of the manner in which the commission perceives and uses its regulatory authority.

Measurement, 2008

Overturned dockets: None

#### **Electric Reliability**

The electric utility industry uses indices to track and benchmark reliability performance. Companies use this data to evaluate and improve upon their response to outages, handling of customer complaints, and system integrity. Though electric utilities in South Dakota are not required to report these scores to the PUC, the companies discuss the information with the commission and a comparison to national scores is ascertained.

#### Indices:

- System Average Interruption Duration Index (SAIDI): The average amount of time a customer's service is interrupted during the reporting period
- System Average Interruption Frequency Index (SAIFI): The average number of interruptions that a customer would experience
- Customer Average Interruption Duration Index (CAIDI): The average outage duration that any given customer would experience. CAIDI can also be viewed as the average restoration time.

Measurement, South Dakota 2008 scores compared to National 2007 average All six investor-owned utilities in South Dakota ranked well below the national average in each of the indices (the lower the score, the better the ranking), signifying the utilities have a high degree of reliability performance.

#### **Grain Warehouse**

Monitoring the South Dakota grain industry is a significant responsibility of the Public Utilities Commission. The PUC Warehouse Division licenses and inspects:

- state-licensed grain storage warehouses.
- federally-licensed grain storage warehouses holding state grain-buyer licenses.
- grain buyers licensed as brokers, truckers and non-storage facilities.
- grain processors and other end users who purchase grain worth \$300,000 or more directly from producers.

The warehouse staff works to reduce producer risk by reviewing the grain buyer and grain warehouse financial statements each year and by performing regular on-site inspections.

The PUC uses three main categories to measure the effectiveness of its work in the grain industry.

#### **Inspections**

The PUC conducts inspections to ensure compliance with statutes and rules related to the licensing and bonding requirements for grain warehouses and grain buyers. The number of inspections conducted describes the penetration of the agency's review process. The commission aims to inspect each licensed facility annually.

Measurement, 2008

Grain warehouse and grain buyer inspections: 302 inspections of 255 licensed locations (118%)

#### Licenses

The PUC issues two types of licenses for grain buyers/grain warehouses doing business in the state. Each licensed entity is required to annually apply for renewal. As part of the licensing and renewal process, the commission analyzes the grain buyers' financial ability to pay grain producers and suppliers. The number of licenses handled by the PUC depicts the wide scope of the commission's monitoring of the industry.

Measurement, 2008

- Class A Licenses (entities that use voluntary credit sale contracts or exceed \$10,000,000 in annual purchases): 125 entities with 239 locations
- Class B Licenses (entities that do not use voluntary credit sale contracts and do not exceed \$10,000,000 in annual purchases): 63

#### **Failures**

When a licensed grain warehouse fails to perform its duties or carry out its obligations to its producers, the PUC follows prescribed laws and administrative rules to investigate, audit or take other necessary action to limit damage to the public. The number of failures, excluding circumstances beyond the commission's authority, can be an indicator of the commission's level of diligence in overseeing the industry.

Measurement, 2008 Failures: None

#### **Pipeline Safety**

The PUC has responsibility to regulate hazardous gas intrastate pipelines which includes ensuring the public is provided safe and dependable gas service. As part of its duties, commission staff inspects and investigates natural gas pipeline operators, master meter operators and propane systems for compliance with statutes and administrative rules.

The commission uses the following measurement tools to establish that it is appropriately handling its role with regard to pipeline safety.

#### **Inspections**

PUC pipeline safety engineers regularly inspect hazardous gas pipeline operators to determine compliance with state and federal regulations. Inspections occur in the areas of records, field, construction, drug and alcohol, public awareness, incident investigation, operator qualification and integrity management. The number of inspection hours logged by the safety engineers is an indicator of the agency's thoroughness in this area. Based on the PUC's certification agreement to administer this program for the U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration (PHMSA), a minimum of 85 inspection days are required.

Measurement, 2008

Inspections: 114 days (85 days required)

#### **Federal Audit**

South Dakota's pipeline safety program is audited annually by the PHMSA's Office of Pipeline Safety (Central Region). The agency reviews the inspections conducted and citations issued by the PUC and evaluates the commission's adherence to its pipeline procedures plan. The result of the federal review indicates the PUC's ability to correctly carry out its obligations related to pipeline safety. The highest possible score is 100 and the lowest score for any state reported in 2008 was 85.

Measurement, reported in 2008 based on calendar year 2007

Audit score: 98.5 out of a possible 100

#### **Federal Certification**

PUC staff involved in pipeline safety inspection are required to complete six training courses to become a certified pipeline safety instructor. The courses are taught by the federal Pipeline Safety Office of Training and Qualifications and are designed to educate Federal and State pipeline safety inspectors in the application of compliance requirements, inspection techniques and enforcement procedures.

Measurement, training/certification to-date

- Program Manager: Six of six required courses plus two elective courses completed.
- Inspector: Two of six required courses completed.

#### **Telecommunications**

The commission has regulatory authority over some telecommunications providers and services in South Dakota. For example, the PUC issues certificates of authority to certain providers; approves switched access rates for local exchange carriers; designates providers as eligible telecommunication carriers and approves plans for investing Federal Universal Service Funds; and arbitrates disputes between providers. In addition, the commission serves as a resource on emerging telecommunications issues.

The commission continually assesses its performance in dealing with telecommunications issues, with specific attention paid to these measurements:

#### **Completed Telecommunications Dockets**

As with the electric and natural gas category, the number of telecommunications dockets completed each year reveals the agency's ability to manage its duties and workload. The measurement also alerts agency officials if the process by which dockets are assigned, analyzed and acted upon by staff and commissioners is appropriate. The number can also act as a meter of the amount of activity, within the commission's jurisdiction, by telecommunications providers in the state. The commission seeks to attain an annual completion goal of 85 percent.

Measurement, 2008

Completed dockets: 141Uncompleted dockets: 11Percentage completed: 92.8%

#### **Overturned Telecommunications Dockets**

Parties that file requests or applications with the Public Utilities Commission and intervenors to those dockets have the right to challenge the commission's decision in circuit court. The number of dockets that are overturned by judicial order is an assessment of the manner in which the commission perceives and uses its regulatory authority.

Measurement, 2008

Overturned dockets: None

#### Line Counts per Population

Line count is a valuable measurement tool in the telecommunications industry. It depicts the pervasiveness of telecommunications service by company or within a specific area. The resulting data, when correlated to the state's population, gives a sense of the number of South Dakotans that have telecommunications service. The commission further analyzes specific company information to help determine if the provider is meeting its obligation to offer services to customers in its service territory.

Measurement, 2007

Line counts per population: 1.37

#### **Consumer Affairs**

The PUC provides a number of services for consumers. The agency's consumer affairs staff is trained to help resolve disputes between consumers and their investor-owned electric, natural gas or telephone service providers. They provide educational information about energy efficiency, consumer protection and making wise utility choices. They also offer guidance and referrals for consumers who may have difficulty paying their utility bills. The commission also administers the South Dakota Do Not Call Registry, helping to enroll consumers on the registry and investigating violations against consumers who are on the registry.

The commission evaluates its performance related to consumer affairs by examining the following areas:

#### Complaints Completed within a Month

Consumer complaints are received by the commission via phone, e-mail and, occasionally, are delivered in-person by the complainant. The PUC strives to quickly and fully investigate each incident by analyzing both sides of the complaint and working with the affected parties to informally reach a resolution. The number of complaints completed within a month reveals the commission's effectiveness in responding to consumers. The goal is 90 percent completed within a month.

Measurement, 2008

Complaints completed within a month: 92%

#### **Formal Consumer Complaints**

When a consumer and utility cannot reach a resolution though the informal process, one of the parties may file a formal complaint. A formal complaint is entered into a docket and, unless settled, may result in a hearing before the commission. The commission endeavors to affect complaint resolutions informally and therefore strives for a low number of formal complaints. This measurement is also an assessment of the commission's negotiation and mediation skills.

Measurement, 2008

Formal consumer complaints: 8

#### Do Not Call Registry

The commission continually uses outreach efforts to educate South Dakotans about enrolling their personal telephone number on the Do Not Call Registry to reduce the number of telemarketing calls they receive. In addition to advocacy, the PUC takes an active role and, at the request of a consumer, will enroll their number on the registry. The PUC tracks the number of South Dakota telephone numbers on the registry, noting the amount of growth each year which is an indication of the success of education efforts.

Measurement, 2008

South Dakota telephone numbers on Do Not Call Registry: 474,511 (24% increase over 2007)

#### REGULATED UTILITY COMPANIES

The Commission has territory, complaint and quality of service authority over all natural gas, electric and telecommunications utilities operating within South Dakota. Certain utilities are exempt from the commission's rate regulation. They include municipal, rural electric cooperatives and small, independent and cooperative telephone companies. The commission retains its switched access rate making authority for all telecommunications companies providing local service, including small, independent and cooperative companies.
