

Mission Statement

Background


The South Dakota Public Utilities Commission consists of three elected atlarge Commissioners each serving staggered, 6-year terms. The Commission has 24 staff members. The Commission is authorized by statute and regulates the rates and service quality of investor-owned electric, natural gas, and telephone utilities and has territorial jurisdiction over all retail electric companies, including cooperatives, independents, and municipals. In addition, the Commission

- registers Interstate motor carriers
- licenses and inspects grain elevators and grain dealers
- operates the natural gas pipeline safety program
- maintains the state's one-call notification cetner which regulates excavation activities.

The Commission also handles consumer complaints involving the service quality of all referenced industries.

Vision Statement:

To become the premier expert, information source, educator and problem solver for all utility matters falling within the public domain.

1998 Headlines

◆ April 17: "South Dakota Commission Chair Jim Burg appointed to NARUC Electricity Committee."

NARUC President Jolynn Barry Butler announced her appointment of PUC Chair Jim Burg to the NARUC Electricity Committee. "Jim's twelve years experience as a commissioner and his continued leadership in NARUC will be valuable to South Dakota and all U S consumers as we proceed with electric restructuring," Butler said.

◆ July 2: "South Dakota PUC Chairman Jim Burg elected President of Mid America Regulatory Commissioners."

PUC Chairman Jim Burg was handed the reins to the Mid-America Regulatory Conference (MARC) held in Overland Park, Kansas. Burg will preside as President of MARC succeeding Susan Seltsam, Commissioner of the Kansas Corporation Commission.

◆ July 24: "PUC Reorganizes to Better Meet Public Needs"

Reponding to rapid industry changes, the PUC implemented a new strategic plan that calls for a new organizational structure. The plan went into effect July 7, 1998 and is designed to keep the PUC better informed and make it more responsive and flexible as it continues to serve and protect the public.

December 18: "PUC Commissioner working to harness wind."

PUC Commissioner Pam Nelson has been appointed to the National Wind Coordinating Committee (NWCC) by Wyoming Public Service Commission Chairman Steve Ellenbecker. The NWCC is the U S Department of Energy's national multi-stakeholder wind commercialization and collaborative council. It was formed in 1994 to promote sustainable domestic US markets for wind technologies.





Electricity

1998 Headlines & Activities

◆ December 10: "South Dakota PUC and Other Low Cost Electric States Voice Deregulation Concerns to Congress."

Today, the South Dakota Public Utilities Commission, along with 22 other State Public Utility Commissions of low cost energy states joined together to inform Congress of various concerns regarding electric restructuring.

- The City of Pierre filed for a declaratory ruling with the assumption that no siting permit would be required for construction of a transmission line looping the city. The Commission ruled that a permit would be required.
- The City of Vermillion annexed property and later notified Clay-Union Electric Cooperative that the city intended to provide electric service on the annexed property. Clay-Union would not consent to the relinquishment of service rights, based in part on federal constitution grounds, and the matter was brought before the Commission. The Commission's ruling, based on South Dakota law, was for the City of Vermillion.
- Electric restructuring has been a matter of discussion both within the Commission and around the state, but there has been no consequent legislative or rule-making activity. the South Dakota Commission has not supported any change, either federal or state.

Natural Gas

- Northern States Power Company (NSP) began its first full year of South Dakota retail natural gas operations. The new entity is using a natural gas pipeline owned by NSP's South Dakota electric operation.
- MidAmerican Energy filed in November to increase South Dakota jurisdictional natural gas rates by \$3.2 million. The Commission suspended the rates pending futher review.
- Ottertail Power Company, an investor-owned electric company, purchased PAM Natural Gas, a retail natural gas marketer which had been operating in South Dakota for several years.

1998 Activities

One-Call Notification

In its fourth year of operation, the South Dakota One-Call Notification Board has contracted with One Call Systems, Inc. of Pittsburgh, Pennsylvania, as its systems operator. The One-Call Notification Board continues to function as an eleven-member board whose members are appointed by the Governor and, by statute, represent various utility and contracting industries.

Pipeline Safety Program

The tranmission and distribution system continues to expand at a steady pace. Approximately 300 miles of pipe and 5,000 new customers were added to the systems in South Dakota during the year. These increases bring the number of miles of pipe to 3,500 and the number of customers to 155,000.

There was one reported incident during the year. On May 30, 1998, the town of Spencer was severly damaged by a tornado. Approximately two-thirds of the town, including the business area, was destroyed or damaged by the storm. One hundred and eleven gas services were either destroyed or lost because of damage. Six people died and over 150 were injured by the storm but none of the damage, deaths, or injuries could be attributed to damage done to the gas system. Damages to the gas system were estimated to be \$74,193.

Telecommunications

◆ February 4: "Judge Upholds PUC Denial of U S WEST Rate Increase"

South Dakota Circuit Court affirms the Commission's decision to deny U S WEST's rate increase on the basis of unsatisfactory service quality.

◆ April 6: "PUC Changes Procedures in Anticipation of New Law"

The Commission dismissed its show cause proceeding against U S WEST in favor of opening a more expansive investigation to identify areas within the entire state where adequate phone service is lacking. The investigation will be followed by a rulemaking proceeding that sets service quality standards for phone service throughout the state.

♦ May 27: "Public Utilities Commission Seeks Input on Present and Future Telecommunications Needs"

The PUC will hold public input meetings to determine the present and future needs of South Dakota telecommunications users. Information gathered at the meetings will be used to establish new service quality standards for telecommunications services.

◆ June 19: "PUC Orders U S WEST to Upgrade Services in the Carpenter, South Dakota, Area"

The PUC issued an order today directing U S WEST to replace its out-dated telecommunications system in the Carpenter, South Dakota, area with three NEC digital line carriers prior to the end of this year's construction season. According to the order, the PUC found that U S WEST had failed to provide customers in the Carpenter area with adequate, reliable telecommunications service. This, the PUC wrote, was detrimental to the public interest.

◆ September 11: "PUC to Impose Penalty If U S WEST Delays Construction"

In a unanimous decision, PUC Commissioners voted to impose a \$1,000 per day penalty against U S WEST if the company fails to meet a September 30, 1998, completion deadline for upgrading its telephone network in Carpenter, South Dakota.

◆ December 11: "PUC Telecommunications Rules to be Considered by Legislature"

The PUC's proposed telecommunications rules establish service quality standards and provide "slamming" and "cramming" prohibitions and consumer remedies. They also address local exchange service competition, interexchange carrier classification, and general rules of practice.

1998 Activities

Telecommunications

- The 1998 Legislature did not establish a universal service fund but it did make significant changes to the state's telecommunications laws. Some the changes include: All Commission regulations pertaining to telecommunications companies shall apply to all telecommunications carriers; the Commission may not order dialing parity for intraLATA long distance until all providers are allowed into the interLATA market; the definition of Local Exchange Service is no longer limited to "two-way switched voice." It is now expanded to two-way switched telecommunication service," which would include voice, data, and video; the threshold size of independent telephone companies subject to Commission rate regulation is raised from 10,000 access lines to 50,000 access lines; Commission approval is no longer required for consolidations or mergers. Companies are now only required to notify the Commission of consolidations or mergers; telecommunications companies may jointly provide facilities and enter into revenue pooling arrangements. They may also form associations and pool resources consistent with state's infrastructure policies. Such activities receive statutory protection from unfair trade practices, antitrust, and restraint of trade laws.
- In addition, the new law states that customers in rural and high cost areas shall have access to services and rates that are reasonably comparable to services and rates in urban areas; any telecommunications company may grant any discounts, incentives, services or other business practice necessary to meet competition; prices for U S WEST's residential and business local exchange service (many now include switched voice, data and video service) are capped by the legislature as of January 1, 1998. If such rates are lowered by the company, they cannot be raised without legislative approval.
- ◆ The Commission promulgated new telecommunications rules for local exchange service competition, service quality standards, interexchange carrier and classification, and prohibitions against slamming and cramming. The new rules became effective on December 27, 1998.
- ◆ Due to excessive consumer complaints of slamming against Utility Analysts, doing business as Basic Long Distance, the Commission ordered the company to appear in a hearing to determine wrongdoing. As a result, all of the company's South Dakota customers were contacted to determine if the services of the company had been requested. The company was ordered to refund, in full, all charges assessed to South Dakotans who did not request their services. The company is no longer doing business in South Dakota and cannot unless telemarketing scripts are submitted for approval.

Telecommunications

- ◆ The Commission does not require CLECs (competitive local exchange carriers) to file reports indicating market share. However, the Commission did receive a total of 78 consumer complaints from three separate CLECs, an indication that the CLECs are attracting customers from the incumbents.
- During the year, the Commission received 54 applications for certificates of authority from interexchange carriers, 1 application from a competitive local exchange carrier, and 4 applications for carriers wanting to do both long distance and local service. At year-end 1998, South Dakota had 246 certified long distance providers, 27 certified competitive local exchange providers and 61 certified local exchange companies. Thirteen long distance companies had their certificates of authority revoked for nonpayment of the gross receipts tax.
- ♦ Eleven formal interconnection agreements are in effect between U S WEST and new, competitive local exchange companies, including six wireless carriers. Only one interconnection agreement exists between two rural telecommunications companies. The Commission has arbitrated one interconnection agreement filed by AT&T Communications of the Midwest on November 20, 1996. This agreement is pending before the Commission.
- ◆ The Commission approved 17 switched access cost studies submitted by the Local Exchange and Carriers Association (LECA), some of its small independent, cooperative and municipal telephone company members and the South Dakota Network.

Transportation/Warehouse Division

- ◆ The transportation/warehouse division licensed and monitored 382 grain dealers and warehouses consisting of 251 grain storage facilities, 50 nonstorage facilities, 47 truck grain dealers and 34 grain brokers. It also approved licenses and required bonding or insurance coverage for 25 general storage facilities. The division registered insurance and issued permits to 1016 single state (SSRS) Federal Highway Authority (previously known as ICC) truckers and 2731 exempt commodity haulers.
- ◆ The division has one part-time and two full-time inspectors who perform 200-400 annual and special inspections per year on grain warehouses and grain dealers. Along with these inspections, the inspectors perform several grain checkoff inspections for the SD Wheat Commission, SD Soybean Council and SD Corn Utilization Council. These inspectors also work with the Motor Carrier Division of the South Dakota Highway Patrol in monitoring truckers passing through the ports and weigh stations by checking for proper authority and grain license truck decals.
- ◆ In an effort to develop cooperative agreements in which companies with multistate locations would have a single inspector perform grain inventory measurements, visual identification of contracts, scale tickets, and other functions, the warehouse division has been working with colleagues in Nebraska, North Dakota, and Minnesota.
- 4 facilities changed ownership in 1998.
- ◆ 1998 saw the introduction of variable storage and handling charges for state-licensed storage facilities. The industry requested the Commission grant authority to adjust storage and handling charges to become more competitive. The Commission adoped a variable rate structure with a 38¢/bushel/year maximum storage rate and a 12¢/bushel maximum charge for loading in and loading out with a 7¢ maximum for each component of the in/out charge. Each facility will now file a rate request annually during license renewal. The Commission will then either approve or disapprove the filing. The facilities will be able to adjust their rates up to 4 times a year if needed.
- The warehouse division began developing a grain measuring component for its inspections. The grain measuring component is extremely valuable as it will help in verifying grain inventory records and in making sure the grain recorded in the books is accurate. The division has made huge strides in implementing this program and feels the industry will be well served by it.

Transportation/Warehouse Division

- ◆ There appears to be a trend developing that involves moving away from stored grain toward Voluntary Credit Sales (VCS) contracts. By doing this the elevator facilities are able to free up grain for shipping, allowing the facilities to handle larger quantities of grain. The poses a risk for producers as the VCS contracts are not covered by the grain dealer or grain warehouse bonds. Therefore, it is imperative that the Commission focus closely on the financial health of all grain dealers within the state, making sure producers are doing business with strong companies that will not default on theses contracts. The Commission has a strong financial analysis program in place; however, VCS contracts heighten the importance of financial monitoring. In light of this, the Commission will only accept financial statements prepared at the audit, review or compilation level. Plan and equipment assets must be stated at cost less depreciation. Market valuations will only be accepted if they are preformed by an independent consultant.
- Another trend concerning Voluntary Credit Sales contracts is the move from basic VCS contracts (Delayed Price, Deferred Payment) to more elaborate hybrid contracts. These hybrid contracts are becoming more complex. There may be a need to educate producers on these contracts. The Commission is determined to keep up-to-date on the new styles of contacts so it will be ready to educate producers if the need arises.

1998 Activities (continued)

Year 2000 Preparation

♦ The Commission opened Docket MS98-001, to survey utility service providers about Year 2000 readiness. The initial survey was due October 1, 1998. To monitor the progress of the utilities' Y2K efforts, each local service provider has been asked to submit three "Critical Checkpoint Cards." The first was due December 31, 1998, the second March 31, 1999, and the last one is due July 31, 1999.

CHEYENNE RIVER SIOUX TRIBE TELEPHONE AUTHORITY AND US WEST COMMUNICATIONS v. PUBLIC UTILITIES COMMISSION, CIV. 95-288

U S WEST Communications, Inc. (U S WEST) filed an appeal in Circuit Court of the Commission's decision that disapproved of the sale of the U S WEST exchanges of Timber Lake, McIntosh, and Morristown to the Cheyenne River Sioux Tribe Telephone Authority (CRSTTA). CRSTTA was granted intervention in the appeal. The issues in the appeal are as follows: (1) whether the Commission has jurisdiction over the sale of the three exchanges to CRSTTA; (2) whether the application of SDCL 49-31-59 to the proposed sales violates equal protection rights; (3) whether the application of SDCL 49-31-59 to the proposed sales is an unconstitutional impairment of contract; (4) whether the proposed sales would result in an improper delegation of authority under SDCL 49-1-17; and (5) whether the Commission's findings that the sales would result in the loss of significant tax revenue for the cities, counties, and school districts are clearly erroneous. The parties have filed their briefs in this matter. Oral arguments were heard on February 2, 1996. The Circuit Court remanded the matter to the Commission which then entered a decision on remand. The matter was appealed a second time to the Circuit Court. The Commission's decisions were affirmed. The case has been appealed to the Supreme Court.

CHEYENNE RIVER SIOUX TRIBE TELEPHONE AUTHORITY v. PUBLIC UTILITIES COMMISSION, ET AL., CIV. 95-3035

On October 27, 1995, the Cheyenne River Sioux Tribe Telephone Authority (CRSTTA) filed a civil action in the United States District Court seeking declaratory, injunctive, and 1983 relief against the Public Utilities Commission and the Commissioners concerning their decision to deny the sale of the U S WEST exchanges of McIntosh, Timber Lake, and Morristown to CRSTTA. The Commission's answer to the complaintant was served on December 12, 1995. The action was dismissed without prejudice on January 23, 1999.

STATE OF MICHIGAN v. DEPARTMENT OF ENERGY, CIV. 95-1321

The Commission joined in a Petition for Declaratory Judgment and Review of Final Decision of the Department of Energy (DOE). The issue is whether DOE's decision that it is not required to begin acceptance of radioactive waste and spent nuclear fuel by January 31, 1998, is contrary to law. The case was briefed by the parties and oral argument was heard before the U S District Court of Appeals, D.C. Circuit on January 17, 1996. On July 23, 1996, the Court ruled that DOE has a statutory obligation to start disposing of the radioactive waste and spent nuclear fuel no later than January 31, 1998. The decision was then remanded back to DOE for further proceedings consistent with the Court's decision. The parties then filed a writ of mandamus requesting declaratory and injunctive relief. The Court granted the writ only in part, finding there were contractual remedies the parties could pursue. The Court's decision was appealed to the U.S. Supreme Court but the writ for certiorari was denied.

IOWA UTILITIES BOARD, ET AL. v. FEDERAL COMMUNICATIONS COMMISSION, No. 96-3321 and Consolidated Cases

The Commission, along with numerous other state commissions and telecommunications companies, filed an appeal with the Eighth Circuit Court of Appeals of the Federal Communications Commission's (FCC) rules interpreting the federal Telecommunications Act of 1996 (federal Act). The Commission, along with three other state commissions, also filed for a stay of the FCC's pricing rules. The Eighth Circuit granted the stay on October 15, 1996. The state commissions' issue was whether the FCC exceeded its jurisdictional authority when it promulgated rules regarding the methodologies to be used in the pricing of network elements and services necessary to provide competitive local exchange service. The state commissions contend that the federal Act left the pricing of network elements and services to the state commissions, not the FCC. Briefs on the merits were filed and oral argument was held before the Eighth Circuit on January 17, 1997. On July 18, 1997, the Eighth Circuit ruled that the FCC exceeded its jurisictional authority when it promulgated the pricing rules. The decision was appealed to the U. S. Supreme Court. The Supreme Court reversed the Eighth Circuit on a number of issues including the issue of whether the FCC exceeded its jurisdictional authority by issuing rules regarding pricing methodologies. The case is on remand back to the Eighth Circuit.

<u>U S WEST COMMUNICATIONS, INC. v. PUBLIC UTILITIES</u> <u>COMMISSION OF THE STATE OF SOUTH DAKOTA, CIV. 97-349</u>

On September 9, 1997, U S WEST appealed the Commission's decision which denied U S WEST's request for a second rate increase to its local exchange services rate. The denial was based upon the evidence of U S WEST's service quality performance as presented at the hearings. U S WEST's issues were as follows: (1) whether the Commission's decision denying U S WEST an increase violated SDCL 49-31-7 and the Due Process Clause of the Fifth and Fourteenth Amendments and Article VI, of the South Dakota Constitution; (2) whether the Commission's decision denying U S WEST an increase to its residential rates other than the touch tone increase should be reversed under SDCL 1-26-36; (3) whether Finding of Fact 19 and Conclusion of Law 3 of the Commission's decision should be reversed under SDCL 1-26-36; (4) whether the Commission's denial of U S WEST's request for an increase to its residential rates constitutes a taking under the United States and South Dakota Constitutions. The Circuit Court affirmed the Commissions decision.

IN THE MATTER OF THE ESTABLISHMENT OF SWITCHED ACCESS RATES FOR U S WEST COMMUNICATIONS, INC., CIV. 97-462

On June 24, 1996 U S WEST filed for approval by the Commission of its 1995 switched access cost study and the resulting switched access rates. The matter was the subject of two administrative hearings, one in October 1996 and another in September 1997. It has been appealed to the Sixth Judicial Circuit Court twice and remanded twice. Upon the last remand, the Commission entered its decision and that was appealed by U S WEST. The parties stipulated to submitting the matter for a third time to the Court upon written briefs. The matter is pending a decision from the Circuit Court.

TED MATHEWS v. ST. PAUL MERCURY INSURANCE COMPANY, SOUTH DAKOTA PUBLIC UTILITIES COMMISSION, INTERVENOR, CIV. 98-0857

On December 23, 1998, the Commission sought intervention in this action for purposes of being appointed a receiver of certain grain dealer bond proceeds and to determine claims to those proceeds. The grain dealer is Britton Durum Corporation, Britton, SD. On December 31, 1998, the Circuit Court appointed the Commission as a receiver. A hearing on the claims was held on February 18, 1999 in Aberdeen, SD and a second hearing was held on May 4, 1999, in Pierre, SD. The Commission has taken the matter under advisement. Commission action is subject to Circuit Court approval.

<u>CLAY-UNION ELECTRIC CORPORATION v. THE CITY OF</u> VERMILLION AND S.D. PUBLIC UTILITIES COMMISSION, CIV. 98-47

On October 20, 1997, the city of Vermillion filed an Application for Determination of Purchase Price of Electric Facilities in Annexed Areas. The Commission issued an Order to Show Cause on February 24, 1998. Clay-Union sought an Order to Stay Proceedings and an Action for Declaratory Judgment in the First Judicial Circuit. The stay was denied and the parties agreed to an indefinite continuance to allow them to proceed with an orderly exchange of service territory and property. The parties filed a Stipulation and Agreement with the Commission on June 30, 1998. On August 5, 1998, the Commission enter its Order Approving Stipulation and Closing Docket. Clay-Union alleges in its Action for Declaratory Judgment that the statutory provisions of SDCL 49-34A are unconstitutional. Briefing is set for October 1, 1999. Oral arguments are set for October 22, 1999.

On June 3, 1998, the Commission ordered extended area service (EAS) between Colton and Sioux Falls and between Dell Rapids and Sioux Falls. Docket TC95-120, In the Matter of the Petition of David Glader for Extended Area Service Between Colton, South Dakota, and Sioux Falls, South Dakota, and Docket TC95-122, In the Matter of the Petition for Extended Area Service between Dell Rapids, South Dakota, and Sioux Falls, South Dakota. Extended area service means that calls are essentially treated as local calls instead of toll calls. On June 17, 1998, these decisions were appealed by U S WEST. In its appeals, U S WEST raised a number of issues, including whether the decisions resulted in an unconstitutional taking of U S WEST's property. The Commission's decisions were affirmed by the Circuit Court, Sixth Judicial Circuit on October 28, 1998. U S WEST did not appeal to the Supreme Court.

<u>U S WEST COMMUNICATIONS, INC. V. PUBLIC UTILITIES</u> COMMISSION OF SOUTH DAKOTA, CIV. 98-73

On February 27, 1998, the Commission received a Notice of Appeal filed by U S WEST concerning the Commission's Order to Show Cause issued in Docket TC97-192, In the Matter of U S WEST Communications, Inc. and its Ability to Serve South Dakota Customers. U S WEST also filed a motion to stay the Commission's show cause proceedings pending the appeal. The motion to stay proceedings was denied by the Circuit Court. The Commission subsequently withdrew its Order to Show Cause and the appeal was dismissed.

1998 Legislative Action

- **SB 153** This legislation was designed to allow a municipality to operate a telephone system outside of the municipality. The bill was tabled in the Senate Local Government committee.
- **SB 164** This bill would have allowed a municipality operating an electric utility system to sell electric energy at retail beyond its corporate limits. The bill was deferred to the 36th day by the Senate Local Government committee.

- **HB 1142** This legislation was designed to allow joint ventures and other arrangements among telecommunications companies to assist in the provisioning of the South Dakota Public Communications Network Infrastructure. It was tabled by the House State Affairs committee but similar language was added into HB 1160.
- **HB 1160** This legislation was designed, in part, to comply with the federal Telecommunications Act of 1996. The bill addresses local competition issues, dialing parity, a cap on local rates, and pricing flexibility. The legislation was signed into law.
- **HB 1173** This bill addressed slamming and required that a company could change a subscriber's designated telecommunications company only if the subscriber confirmed the change in writing or the change was confirmed by a third-party verification company. The legislation was signed into law.
- **HB 1215** This legislation would have set up an universal service fund for the provisioning of telecommunications services in high-cost, rural areas. The bill was tabled by the House State Affairs committee.
