Commissioner Ken Stofferahn (Democrat) is serving his third term on the Public Utilities Commission. He was first elected to the PUC in 1978, after serving in the South Dakota House of Representatives in 1975-76. Ken was a member of the West Central School Board in Humboldt from 1974-1978. He was president of the board in 1974.

He graduated from Humboldt High School in 1952 and South Dakota State University in 1957 with a B.S in Agriculture. From 1957-1963 he served in the Air National Guard. Ken attended the National Judicial College in 1981, and the Annual Regulatory Studies Program at Michigan State University in 1981, 1982, and 1987.

Currently, Ken is serving on the Committee on Electricity and a Subcommittee on Environment for the National Association of Regulatory Utility Commissioners. He has served as a board member of the National Regulatory Institute at Ohio State University from 1985 through 1992, achieving a record tenure in that capacity.

His service memberships include the Elks, Masons, Shrine, and Kiwanis. His hobbies include: "Kids, Cars, Old Dogs, and Watermelon Wine", with a little gardening, and a record collection thrown in.

# Jim Burg

Commissioner Jim Burg (Democrat) was elected to the Public Utilities Commission in 1986, and won his second term in November of 1992. He was elected to the South Dakota House of Representatives in 1974, and served five terms. He was elected to the South Dakota Senate in 1984 and served one term.

He graduated from Lane High School in 1959 and South Dakota State University with a B.S. in Animal Science in 1963. He was Fieldman for the Federal Land Bank from 1964-1967 at which time he returned to the family farm at Wessington Springs. He operated the farm from 1967-1986. He served in the South Dakota National Guard from 1963-1990, retiring as a Lt. Colonel.

Jim was Chairman of the Jerauld County Democrats from 1973-74, and served on the Executive Board of The South Dakota Democratic Party. Past honors include Blue Key Honor Society and Jaycees Outstanding Young Farmer and Outstanding Young Religious Leader. Honorary State FFA Degree, Honorary Chapter Farmer (FFA) - Outstanding 4-H Alumnus.

Jim is a past board member of the South Dakota Chamber of Commerce and past board member and secretary-treasurer of the South Dakota Retailers Association. Other organizations include Knights of Columbus, Farm Bureau, and Farmers Union. He is Chairman of the Administration Committee for the National Association of Regulatory Utility Commissioners. The Gross Receipts Tax Fund Revenue shows the amount of annual intrastate gross receipts tax paid by each rate-regulated natural gas, electric and telephone company in South Dakota. This annual intrastate gross receipts tax is authorized by SDCL 40-1A-3 and entirely and exclusively funds the Commission's Fixed Utility Division. This funding source appears as "other" funds under the Fixed Utilities in the Fiscal Report. All monies for the operation of the Commission are appropriated by the legislature.

**HIGHLIGHTS OF 1992** 

## COMMISSION RECLASSIFIES TELECOMMUNICATIONS SERVICES

On February 11, 1992, the Commission opened a Docket on the possible reclassification of telecommunications services. A public hearing was held on October 6 and 7, 1992, in Pierre. On October 13, 1992, the Commission made its final decisions in this Docket: (1) Radio Common Carrier services were reclassified from noncompetitive to fully competitive with a five year delayed implementation (Commissioner Stofferahn dissented with regard to delayed implementation). (2) MTS and WATS were reclassified from emerging competitive to fully competitive for everyone except USWC. (3) Special Access and Private Line Tariffs were merged, and they will continue to be classified as fully competitive. (4) Public and Semi-Public pay phone services were reclassified from noncompetitive to fully competitive. (5) Centrex services were reclassified from emerging competitive to fully competitive, with the exception of the local loop, which remains noncompetitive. (6) Touch Tone service was reclassified from fully competitive to noncompetitive. (7) Listing Services were reclassified from noncompetitive to fully competitive. (8) Radio Common Carrier services, pursuant to SDCL 49-31-4.1, are to be priceregulated.

## COMMISSION GIVES GREEN LIGHT TO NORTHERN BORDER FOR CONSTRUCTION OF COMPRESSOR STATION NO. 9

On October 10, 1991, Northern Border Pipeline Company notified the Commission that it was proposing to construct Compressor Station No. 9 in Edmunds County, South Dakota. Compressor Station No. 9 was part of the facilities authorized by this Commission to be constructed pursuant to the Commission's Decision and Order in Docket F-3364, dated April 13, 1981. On February 27, 1992, the Commission held a public input hearing in the Edmunds County Courthouse in Ipswich. On March 10, 1992, the Commission certified that Northern Border's proposed construction did indeed continue to meet the conditions upon which the original permit was granted.

## COMMISSION CUBICLES AND CAVES REMODELLED INTO MODERN OFFICE SPACE

The Commission attempted, since 1983, to get its office space remodelled; it finally happened in 1992. In March of 1992, Commissioners and Staff left their office space on the first floor of the Capitol and moved into temporary offices in the Capitol basement. The remodelling general contractor, Harvey Wald of Pierre, completed the project in late July--at budget and within the estimated time. The Bureau of Administration provided excellent guidance throughout the entire project. In December of 1992, the Commission's Transportation/Warehouse staff moved to the second floor of the new Retailers Plaza, built on the corner of Capitol and Nicollet. The remodelling project accomplished several goals: (1) All asbestos was removed from the floor and exterior perimeter of the Capitol space. (2) The Capitol office now conforms to State Fire

Codes and is wired into the Capitol's fire alarm system. (3) Private offices have replaced cubicles, achieving more privacy, individual climate control, assurance of confidentiality for consumers and companies, pride of place, and long-term lower maintenance costs. (4) The new Cactus Conference Room (thus named by Mac McCracken of USWC), now furnished with the legislative sound system, is available for wide use. (5) The new direct digitally-controlled HVAC system in the Capitol office ensures climate control within +/- .5 degree F. The ventilation rate is now twice the ASHRAE standard. (6) The PUC's remodeled Capitol space and new Retailers Plaza space both strictly comport with the provisions of the Americans with Disabilities Act.

## SDIP FILES FOR A PERMIT TO CONSTRUCT TRANSMISSION FACILITIES AND ALSO FILES AN ASSOCIATED RATE CASE

On March 31, 1992, the Commission received an Application For Construction Permit from Walter Woods of the South Dakota Intrastate Pipeline Company (NG92-002). SDIP was seeking Commission approval of a permit to construct a natural gas transmission pipeline and associated facilities in Edmunds, Walworth, Potter, Sully, and Hughes Counties. Specifically, the plan called for hooking into the Northern Border Pipeline in eastern Edmunds County and running transmission lines west along U.S. 12 to Selby and then south along U.S. 83 to Pierre. According to the Application, "The purpose of the facility is to supply natural gas to entities including, but not limited to, the municipality of Pierre." SDIP filed an associated rate case (NG92-005) on April 28, 1992. In May, the Commission held public input meetings in the siting case in Pierre, Onida, Gettysburg, Selby, and Roscoe. A formal hearing was held on September 23, 1992, in Pierre. On September 28, 1992, the Commission granted the construction permit.

## MINNEGASCO FILES, LATER WITHDRAWS PILOT PROGRAM TO IMPLEMENT A WEATHER NORMALIZATION ADJUSTMENT PROVISION

On April 2, 1992, Minnegasco filed for Commission approval a Weather Normalization Adjustment (WNA) clause as a three year pilot program to mitigate the impact of abnormal weather on customers' heating bills and on Minnegasco's margin revenues. The company wrote: "The proposed WNA is a mechanism that adjusts rates slightly downward or slightly upward for weather sensitive customers so Minnegasco

has a more reasonable opportunity to generate the same operating margin that would have been generated assuming the normal weather conditions approved by the Commission." A consumer input hearing was held in Sioux Falls on July 23, 1992. Almost all the public comment received at that meeting and in various letters to the Commission was negative. On August 10, 1992, Minnegasco withdrew the WNA filing.

## COMMISSION OPENS DOCKET TO ADOPT ADMINISTRATIVE RULES FOR INTRASTATE SWITCHED ACCESS

On April 9, 1991, the Commission opened a Docket to investigate the adoption of a uniform access methodology and to investigate the establishment of a statewide pool to average all intrastate access rates. The Docket was later bifurcated into TC91-040A (methodology) and TC91-040B (pool). A public hearing was held on March 24, 25, and 26, 1992 in

Sioux Falls. On July 21, 1992, the Commission voted on 32 issues under TC91-040A and three issues under TC91-040B. Rulemaking Docket RM92-001 was then opened. The public hearing in RM92-001 was held on November 17, 1992, in Sioux Falls. The new access rules became effective on February 1, 1993.

## COMMISSION INVESTIGATES CLASS B LIVESTOCK, GRAIN, AND OTHER COMMODITY RATES ESTABLISHED IN TARIFF NO. 65, SUPPLEMENT NO. 1

The Commission initially began an investigation into Tariff No. 65 in the summer of 1991. On April 29, 1992, the Commission voted to convert the livestock rate from an absolute rate to a maximum rate but to leave the grain tariff unchanged. On May 19, 1992, the Commission voted to reconsider its decision. A rehearing was held on June 22, 1992. At the conclusion of that rehearing, the Commission rendered a 3-0 bench decision, returning the livestock rates from maximum to absolute.

## INTERIM APPROPRIATIONS COMMITTEE GRANTS PUC'S REQUEST FOR ADDITIONAL FUNDING TO COVER COSTS OF TRUCKING AUDIT

On June 19, 1992, Commissioners and Staff appeared before the Legislature's Interim Appropriations Committee to request \$11,640. The amount covered about three-fourths of the actual expenses directly related to a bills-of-lading audit of trucking companies conducted during

the summer of 1991. That audit had been made by summer interns Lyle Brady, Carla Eidahl, and Kara Donovan. Commissioner Schoenfelder made the oral presentation before the Committee, which then voted to grant the PUC's request.

## NSP FILES ELECTRIC RATE INCREASE REQUEST

On June 29, 1992, NSP filed with the Commission a retail electric rate increase request of \$6.347 million or 9.8% (EL92-016). The filing included requested treatment of Financial Accounting Standard 106 (FAS 106), Employers Accounting For Post-Retirement Benefits Other Than Pensions (PBOPs). On November 13, 1992, the Commission approved a Settlement Agreement between NSP and Commission Staff; the Agreement covered all rate case issues except

FAS 106. The settlement agreement reflected an increase in South Dakota jurisdictional rates of \$4.220 million (6.5%) in two stages: an increase of \$3,801,000 to become effective January 1, 1993, and an increase of \$419,000 to be effective May 1, 1993. On December 15, 1992, the Commission voted to continue PAYGO accounting as opposed to accrual accounting) for PBOPs for ratemaking purposes.

## A SIGN OF THE TIMES

On June 30, 1992, the interim manager of Turton Farmers Elevator informed the Commission that they would be unable to provide the surety bonds necessary to stay open as a grain warehouse and grain dealer. During their initial investigation on July 1, 1992, Commission staff determined that Turton had insufficient assets to satisfy outstanding grain liabilities to area producers. Twenty four claims were submitted against

Turton's grain warehouse and grain dealer bonds. All but two claims were paid through bond proceeds or the sale of stored grain. The other two claims involved voluntary credit sales contracts which are not covered under bond. A total of \$36,098.08 was paid to those who submitted claims. The outstanding liability which was not covered by bonds and remains unpaid is \$98,809.

## TRANSPORTATION/WAREHOUSE DIVISION STINGS QUAST TRANSFER

During the summer and early autumn of 1992, the Commission received several complaints alleging illegal intrastate shipment of products by Quast Transfer. On September 25, 1992, Commission Staff followed a shipment of computer components from Rapid City to North Sioux City. Quast did not have authority to transport the components to North Sioux City without first routing the shipment through their

Winsted Minnesota terminal. Commission staff were able to prove that the September 25 shipment never left the state on its way to North Sioux City. A subsequent investigation revealed an additional 109 possible illegal shipments of the components. A complaint was filed with the Union County States Attorney and attempts are being made to settle the complaint out of court.

## MIDWEST EXECUTIVE DIRECTORS MEET IN THE BLACK HILLS

On October 10 through 13, 1992, representatives of 10 midwestern states gathered at Blue Bell Lodge, just east of Custer, South Dakota, for the annual meeting of the Midwest Executive Directors. Shirleen Kennedy, Kathy Lucas, and Marshall Damgaard hosted the group in a variety of activities, which included a jaunt up Harney Peak and a session on How To Get Along With Commissioners, starring South Dakota's 3C's.

## BLACK HILLS CORPORATION FILES FOR AN INCREASE IN ELECTRIC RATES UNDER A RATE STABILITY PLAN

On October 30, 1992, Black Hills Corporation filed with the Commission an Application (EL92-026) for a rate stability plan (SDCL 49-34A-73 through 49-34A-78) and to increase electric rates for its South Dakota retail customers. Associated with the rate stability plan was BHC's intention to build an 80 MW power plant (Neil Simpson #2) at Wyodak, Wyoming. On November 19, 1992, BHC filed with the Commission a Petition For Declaratory Ruling (EL92-027). The Petition was directed at Rosebud Technologies of Boise, Idaho, which had contacted BHC about building a 40 MW qualified facility in Edgemont, South Dakota. Rosebud's proposed power plant would burn petroleum coke.

## JIM BURG DEFEATS KEN MAY TO WIN RE-ELECTION TO THE PUC

On November 3, 1992, Democrat Jim Burg became only the second incumbent PUC Commissioner to win re-election in the past 30 years. (Commissioner Ken Stofferahn was reelected twice during those three decades.) Burg defeated Republican challenger Ken May of Rapid City 53.72% to 46.28% (172,821 to 148,881). Vice President of Dakota Steel, May is a Vietnam veteran who has a civil engineering degree from the School of Mines and Technology. May would have become the first engineer elected to the PUC. Appearing late in the campaign, Ken May's television ad ("There goes Jim Burg!") painted Burg as the PUC's frequent flier, attending a host of out-of-state utility regulatory meetings. The 30-second spot, easily the most colorful political commercial in South Dakota that autumn, pictured Burg wearing a straw hat and sitting in a swimming pool surrounded by beautiful babes. Political armchair quarterbacks disagreed over the effectiveness of the spot. Some felt that it cleverly focused the widespread anti-incumbent sentiment toward Burg. Others felt that it was counterproductive in that it bought more name recognition for Burg.

## COMMISSION ADOPTS SEXUAL HARASSMENT POLICY

On November 24, 1992, the Commission adopted a policy stating that "all employees (Staff and Commissioners) are responsible for ensuring that the work place is free from sexual harassment". A synopsis of the policy was added to the PUC Employee Fact Sheet.

## CRIMINALS ON PARADE: GRAIN WAREHOUSES VICTIMIZED BY FOXES GUARDING HENHOUSES SYNDROME

Two South Dakota men received prison terms in connection with the theft of grain from Ferney Farmers Elevator in Groton between May 1990 and April 1991. Elevator employee Dominic Dolney and Pierpont farmer David Aadland were both originally charged with numerous counts of grand theft and theft by deception. In a plea bargain arrangement, Aadland pleaded guilty to one count of theft by deception and received a 10 year prison sentence with all but one year suspended. Dolney pleaded guilty to one count of grand theft and one count of theft by deception and received a 10 year sentence on each charge. The two 10 year sentences will run concurrently. Dolney was also ordered to pay \$73,000 in restitution to the elevator.

## COMMISSION CONTINUES EDUCATIONAL TOURS AND OUTREACH ACTIVITIES

## LIKE SANDS THROUGH THE HOURGLASS: ARRIVALS AND DEPARTURES

During the winter of 1991-92, the Commission engineered a nationwide search for a seasoned telecommunications policy analyst. The vehicle for the search was a job announcement patterned after 19th century immigration posters: "Opportunity Of A Lifetime! The Frontier Is Still Open!" Over 30 people applied for the position. We interviewed five finalists and unanimously voted for a West Virginia cowboy from Alaska, Charlie Bolle. Yes, he talks funny. Charlie joined the PUC in January, as did staff attorney Gus Jacob. A native of DeSmet, South Dakota, and a former military judge, Gus and his girlfriend once drove a car into the Big Sioux River near Teddybear Woods. Consumer Representative Della Andre announced in February that she would soon be leaving the Commission. In March, Kathy Lucas joined the PUC as Della's successor. Kathy previously worked elsewhere. In March of 1992, the Commission collapsed the positions of Transportation Division Director Jolene Nelson and Public Information Officer Geoff Simon. Ed Anderson, who had been Director of the Warehouse Division, was named Director of the Transportation/Warehouse Division. Jolene's FTE was used to provide temporary help (in the person of Judy Smith) during the trucking registration period. Geoff's FTE remained unfilled for over a year; it ultimately will be filled with a utility rate case analyst in May of 1993. Leta Nolan, a reporter for the Pierre Capitol Journal, wrote a long series of front page articles attacking the Commission over its personnel changes. Not one other South Dakota newspaper picked up the story, and Leta's real motivation for the hatchet job remains to this day a mystery. On September 21, 1992, Craig Anderson resigned from his position as Vice President - Chief Financial Officer of Dial-Net. He later became a big deal with the Austad golf equipment empire in Sioux Falls.

## **Consumer Report for 1992**

Although communications initiated by consumers to the Public Utilities Commission are generally referred to as "complaints", perhaps a more appropriate word is "contacts", as many of the calls received by the PUC are actually inquiries about regulation, rules, and statutes, as well as requests for financial assistance. The PUC attempts to answer every question, and also to refer consumers to the appropriate agencies which can assist them.

The nature of contacts varies greatly, but they usually fall into one of the following categories: Service, Deposit, Meter, Disconnect, Boundary/Territory, Tariff/Rates, Billing, Rate Increase, 900 Numbers, and Slamming (Unauthorized switch of long distance carrier.

The Public Utilities Commission received over 100 complaints in February and March 1992 about a "promotion" sponsored by Sweepstakes Clearinghouse, located in Texas.

Consumers received notification by mail that they had won one of several "fabulous prizes", and could learn what their prize was by calling an 800 number. After dialing the 800 number, consumers were told that they could write to Sweepstakes Clearinghouse and wait four weeks to hear what they had won, or they could find out immediately by pressing the number 1 on their telephone. The pre-recorded message stated that they would not be charged "for the call itself" but would be billed separately by Audio Telecom at \$3.90 per minute for "interactive services".

The "prize" turned out to be certificates which could be used to purchase items from a catalog at inflated prices.

Sweepstakes Clearinghouse sent a letter to the PUC stating that "in light of the number of inquiries received" and consistent with their "desire to develop satisfied customers", they would suspend the promotion. Eventually, all customer charges were dropped or refunded, with the average refund being \$15.60.

Due to numerous "promotions" of this type, the FCC has now promulgated rules prohibiting most charges incurred as the result of dialing an 800 number. This was done in accordance with the "Telephone Disclosure and Dispute Resolution Act" which was passed in 1992. Hopefully, this action will help to protect the integrity of 800 numbers as toll free calls.

Another federal law, the "Telephone Consumer Protection Act" (TCPA), a federal statute that was enacted on December 20, 1991, addresses concerns about the growing volume of unsolicited telephone calls and the increasing use of automated and prerecorded telephone calls. The law also bans the transmission of unsolicited advertisements to telephone facsimile machines.

## COMMISSION HAS A BUSY YEAR IN THE 1992 LEGISLATIVE SESSION

The Commission pre-filed several bills with the 1992 Legislature. In addition there were several other bills that affected the Commission and its statutory duties. The following is a list of those bills:

SB 67 Revised the procedures relating to the moving of buildings under utility lines, including: the amount of notice to be provided by the moving party; notification re the time of the move; a reasonable advance deposit approximating the estimated cost of the move; and the itemization, by the utility, of the cost of moving a utility's lines. SB 67 passed the Senate 34-0 and the House 62-0. It was signed into law by the Governor on February 28, 1992.

**SB 74** Provided that the Commissioners salaries be set by the Bureau of Personnel rather than by the legislature in statute. With strong support from the state's utility companies, SB 74 passed the Senate 29-6 and the House 60-8. It was signed into law by the Governor on February 20, 1992.

SB 75 Was a comprehensive review and revision of all telecommunications statutes under the Commission's jurisdiction. This was the first revision of the telecommunications deregulation bill passed by the 1988 Legislature (SB 42). SB 75 passed the Senate 35-0 and the House 67-0. It was signed into law by the Governor on February 28, 1992.

**SB 137** Made any subsequent motor carrier violation of SDCL Chapter 49-28 in a six month period a Class 1 misdemeanor rather than a Class 2 misdemeanor. In addition, SB 137 expanded the radius of all Class B livestock, agricultural products, farm equipment, animal feeds or fertilizer carriers to a 100 mile radius, unless the radius of a carrier's permit was already greater than 100 miles. SB 137 passed the Senate 34-0 and the House 63-2. It was signed into law by the Governor on February 20, 1992.


**SB 149** Abolished the requirement that Commissioners be nominated by districts within the state and revised the qualifications to be elected to the Commission. SB 149 passed the Senate 32-0 and the House 54-11. It was signed into law by the Governor on March 16, 1992.

SB 219 Provided for the inspection and regulation of certain gas and hazardous Inquid pipelines by the Commission. SB 219 passed the Senate 35-0, but was amended in the house, 55-12, to require a summer study only. The bill died in conference committee.

**HB 1088** Revised the methods by which the Commission sets grain warehouse storage, handling and redelivery rates; provided for the measurement of grain warehouse inventories; provided for the delivery of Commission grain storage reports to state or federal agencies; provided for rulemaking authority regarding financial reports submitted to the Commission for grain warehouse or dealer licensure; and provided for the assessment of civil fines by the Commission against persons who violate grain warehouse or dealer statutes under the Commission's authority. HB 1088 passed the Senate 34-0 and the House 67-0. It was signed into law by the Governor on February 21, 1992.

**HB** 1121 Provided that utilities can file rate stability plans with the Commission for approval to reduce rate shock that may be caused by significant increases in purchased power or the addition of new facilities. HB 1121 passed the Senate 33-0 and the House 65-4. It was signed into law by the Governor on February 13, 1992.

HB 1243 As amended required motor carriers to keep copies of their PUC permits in each vehicle and provide a copy to shippers or law enforcement officers upon request and to certify on each bill of lading issued by them that they have the proper authority and insurance to carrier that load. HB 1243, as amended in the House, passed the Senate 20-13 and passed the House 66-1. It was signed into law by the Governor on March 16, 1992.

## COMMISSION HAS AN ACTIVE YEAR BEFORE THE COURTS

#### **TELECOMMUNICATIONS**

In The Matter Of The Proposed Brookings To Sioux Falls Joint Lightwave Toll Facility In South Dakota, F-3699; In The Matter Of The Application Of South Dakota Network, Inc. And SDCEA, Inc., For Permission To Construct Centralized Equal Access Facilities, F-3860; In The Matter Of The Application Of Brookings Municipal Telephone, Interstate Telecommunications Cooperative, Inc., McCook Cooperative Telephone Company and Sioux Valley Telephone Company To Construct Noncompetitive Telecommunications Facilities, F-3866

Each of the above dockets was initiated by filings with the Commission on August 4, 1987 (F-3699); October 6, 1989 (F-3860); and November 6, 1989 (F-3866). The South Dakota Network (SDN) is a centralized fiber optic equal access telecommunications network that was formed by 12 South Dakota local exchange companies (LECs) to provide modem telecommunications services in eastern South Dakota. The Commission issued its final orders in each respective docket on: F-3699 - August 19, 1991; F-3860 - April 12, 1991; and F-3866 - June 12, 1991. In each of the dockets, the Commission granted a construction permit authorizing the construction and operation of the individual facilities which combined form SDN (Commissioner Schoenfelder, dissenting regarding SDN's authority to exclusively carry all terminating switched access to SDN member exchanges). SDN terminates in Sioux Falls, South Dakota, which is in U S West Communication's (USWC) local exchange territory. USWC appealed each of the Commission's decisions to the Sixth Circuit Court, Hughes County. The cases were consolidated on appeal to the Circuit Court by order dated August 2, 1991. The issues in all three cases were essentially the same. In the appeal, USWC contended that the Commission erred in law when it granted SDN the exclusive right to terminate switched access traffic to the local exchanges of the 12 SDN members. By an order dated February 5, 1992, Circuit Court Judge, James W. Anderson, affirmed the Commission's decisions in each docket. USWC appealed Judge Anderson's decision to the Supreme Court on April 1, 1992. At the time of this publication, the parties to the appeal have provided briefs and oral argument to the Supreme Court and are awaiting the decision of the Court.

#### In The Matter Of The Complaint Of U S West Communications Against Brookings Municipal Utilities And Interstate Telecommunications Cooperative, Inc., F-3871; In The Matter Of The Complaint Of Brookings Municipal Utilities Against USWC and AT&T Concerning Private Line And Special Access Services, TC91-116

On November 27, 1989, U S West Communications (USWC) filed a complaint against Brookings Municipal Telephone Co. (Brookings) and Interstate Telecommunications Cooperative, Inc. (ITC) alleging that Brookings and ITC had failed to comply with a settlement agreement entered into among the three parties in Commission Docket F-3710. (USWC had filed a complaint earlier against Brookings and ITC in Docket F-3710.) In F-3710, the three parties signed a settlement agreement whereby Brookings and ITC agreed to build a new fiber optic line from the City of Brookings to connect with USWC's facilities east of Volga, South Dakota. In both F-3710 and F-3871, USWC sought fiber optic access to Brookings's and ITC's networks within the City of Brookings and was denied access. In Docket F-3871, USWC alleged that Brookings and ITC had failed to fulfill the stipulation entered into in F-3710 by not constructing the fiber optic line requested by USWC. After answers to the complaint were filed by Brookings and ITC, the Commission deferred further action in the docket pending a Commission decision in F-

3860 (SDN). Both Brookings and ITC are members of SDN. The deferral was granted by the Commission because the decision in F-3860 may have resolved USWC's complaint. The decision in F-3860 did not, however, resolve the special access and private line issues in this docket. Therefore, after the SDN decision was issued by the Commission, USWC amended its complaint in F-3871 on May 22, 1991, and Brookings and ITC filed amended answers on June 12, 1991. On October 7, 1991, USWC filed an additional complaint with the Commission against Brookings regarding special access disputes in TC91-103. USWC voluntarily withdrew this complaint on October 22, 1991. On November 5, 1991, Brookings filed a complaint against USWC and AT&T in Docket TC91-116. In count one of the complaint, Brookings requested that USWC be prohibited by order of the Commission from providing gray private line services within the City of Brookings in count two, Brookings alleged that AT&T refused to cross-connect Brookings' special access circuits at AT&T's point of presence in Sioux Falls and that, together with USWC, AT&T had discriminated against Brookings in the provision of common carrier services. Brookings requested damages under both counts. The Commission held a hearing on F-3871 on November 6, 1991. The Commission granted AT&T's Motion to Dismiss count two, which was filed on November 18, 1991, in TC91-116, for lack of subject matter jurisdiction. The Commission determined that it did not have jurisdiction over the interstate circuits at issue in Brookings' complaint. However, the Commission found probable cause to proceed with cont on regarding USWC's providing private line services in the City of Brookings. Dockets F-3871 was sufficient to resolve both disputes. After briefing both cases, the Commission found probable cause to proceed with constored the assonate characted by USWC, the Commission's decision required Brookings and ITC to construct a fiber optic line from the City of Brookings to USWC's meet point east of Volga. South Dakota, w

#### In The Matter Of The Registration And Access Tariff No. 1 Of The Local Exchange Carriers Association, TC90-096

On December 14, 1990, the Local Exchange Carriers Association (LECA) filed its Tariff No. 1 with the Commission. LECA is an association of independent local exchange carriers which was formed to jointly file and administer switched access tariffs for its members. By order dated October 9, 1991, the Commission approved a settlement among the parties to the docket that provided for a stipulated switched access rate for LECA's members and approved LECA's registration as a telecommunications company. Dial-Net, Inc. (Dial-Net) and Dakota Cooperative Telecommunications, Inc. withdrew from the proceedings prior to the Commission's approval of the settlement. Dial-Net filed a Notice of Appeal on September 18, 1991, in the Second Circuit Court, Minnehaha County. Dial-Net questioned the settlement approved by the Commission. Dial-Net voluntarily stipulated with the Commission on October 25, 1991, to dismiss its appeal.

#### In The Matter Of The Registration Of Express Communications, Inc. As A Provider Of Intrastate Telecommunications Services In The State Of South Dakota, TC91-001

On January 1, 1991, 26 independent local exchange companies formed Independent Long Distance Company to provide long distance services to their local exchange customers. The company was later renamed Express Communications, Inc. (Express). After briefing the issues in the case, the Commission approved Express' tariff and registration (Commissioner Schoenfelder, dissenting). Dial-Net filed a Notice of Appeal with the Second Circuit Court, Minnehaha County, on April 21, 1992. Dial-Net sought review of the Commission's approval of Express' tariff. Shortly after the appeal was filed, Express and Dial-Net entered into negotiations and agreed to dismiss the appeal. Pursuant to the stipulation, the appeal was dismissed by order of the Court dated December 21, 1992.

#### In The Matter Of The Registration Of Telamarketing Investments LTD., DBA TMC Long Distance To Provide Intrastate Message Toll Telecommunications Service Primarily In Eastern South Dakota And For The Establishment Of Initial Rates And Tariffs, TC91-053

TMC Long Distance (TMC) filed its initial tariff and request for registration with the Commission on May 24, 1991. The Commission issued an Order Approving Registration on December 10, 1991, and an Order Approving Tariff (Commissioner Schoenfelder, dissenting) on February 14, 1992. Dial-Net filed a Notice of Appeal with the Second Circuit Court, Minnehaha County, on March 13, 1992. Dial-Net challenged the appropriateness of the Commission order allowing the combining of intrastate and interstate traffic when calculating volume discounts. On May 11, 1992, the Court consolidated this appeal with TC91-055 entitled In The Matter Of The Complaint Of Dial-Net, Inc. Against Midco Communications Usage Rate Structure. TC91-055 was filed with the Commission on May 30, 1991, and was a complaint brought against Midco Communications (Midco) by Dial-Net. Dial-Net complained that it was

unlawful and discriminatory for Midco to combine intrastate and interstate traffic to calculate a volume discount for a customer. The Commission issued its Order Dismissing Complaint on February 21, 1992 (Commissioner Schoenfelder, dissenting). Dial Net appealed the Commission's order to the Second Judicial Circuit, by Notice Of Appeal dated March 12, 1992. After the cases were consolidated, Circuit Judge Judith Meierhenry issued a written memorandum decision on November 1, 1992, affirming the Commission's decision in all respects. Dial-Net did not appeal Judge Meierhenry's decision to the South Dakota Supreme Court.

#### In The Matter Of The Application Of Brookings Telephone Co. To Revise Its Local Exchange Franchise Service Territory, TC91-107

Brookings Municipal Telephone Co. (Brookings) filed an application with the Commission on October 18, 1991, to provide telecommunications service and expand its service territory into a proposed industrial park recently annexed by the City of Brookings. The City of Brookings had previously annexed four parcels of land, one of which was the industrial park. Interstate Telecommunications Cooperative, Inc.'s (ITC) service territory surrounds the City of Brookings and includes all the territories annexed by the City of Brookings. ITC protested Brookings' request to serve the new industrial park. Two prior annexation/service disputes between these two parties have previously gone before the South Dakota Supreme Court. Based on the Supreme Court's last ruling, the Commission determined, by an order dated May 15, 1992, that Brookings has the right to expand its service territory into the proposed industrial park (Commissioner Schoenfelder, dissenting). On June 8, 1992, ITC appealed the Commission's order to the Sixth Circuit Court, Hughes County, claiming that the Commission had deprived ITC of its service territory without just compensation. By order dated October 13, 1992, Circuit Judge Steven L. Zinter affirmed the Commission's decision. ITC appealed Judge Zinter's decision to the Supreme Court.

#### **ELECTRICITY**

#### In The Matter Of The Complaint Of Northern States Power Company Against Sioux Valley Empire Electric Association For Provision Of Electric Service To Myrl And Roy's Paving, EL91-003

Northern States Power (NSP) filed a complaint against Sioux Valley Empire Electric Association (Sioux Valley) with the Commission on March 25, 1991. NSP sought an order from the Commission to require Sioux Valley to cease and desist from providing electric service to Myrl and Roy's Paving. Myrl and Roy's Paving owned a quarry which was divided by the service territories of NSP and Sioux Valley. By order dated June 12, 1991, the Commission determined that NSP had the exclusive right to serve the quarry since the majority of Myrl and Roy's electrical load was within NSP's service territory (Commissioner Burg, dissenting). Sioux Valley appealed the Commission erred in law when it adopted a majority load test. Circuit Judge Steven L. Zinter affirmed the Commission's decision by an order entered on November 20, 1991. Sioux Valley appealed Judge Zinter's decision to the Supreme Court on January 9, 1992. The Supreme Court affirmed the Commission's decision by an opinion dated July 30, 1992.

#### In The Matter Of The Application Of Northern States Power Company For Authority To Increase Electric Rates In South Dakota, EL92-016

NSP filed a general rate case with the Commission on June 29, 1992, requesting an increase in its electric rates. One of the significant issues in the rate case involved a change by the Financial Accounting Standards Board (FASB) in the accounting of post retirement benefits other than pensions (PBOPs), which consist primarily of medical benefits. FASB issued Statement of Financial Accounting Standard (SFAS) No. 106 which mandates that companies use an accrual method of accounting for financial reporting of PBOP expense. Historically, utilities under the Commission's rate jurisdiction have accounted for PBOPs under a cash or pay as you go (PAYGO) accounting method. Under PAYGO, utilities incur a PBOP expense when they pay for the benefit. The Commission notified all rate regulated utilities that it would rule on SFAS 106 in this docket and allowed intervention. All rate regulated electric and gas utilities intervened. After hearing the issue, the Commission issued an order on January 26, 1993, which approved the continuation of PAYGO accounting for PBOPs. Minnegasco appealed the Commission's decision to the Sixth Circuit Court, Hughes County, on February 5, 1993. Minnegasco had previously reached an agreement to exchange its South Dakota gas properties with Midwest Gas for Midwest Gas's properties in Minnesota and a cash payment. On February 4, 1993, Midwest Gas filed an application to acquire Minnegasco's South Dakota file an application to acquire Minnegasco's South Dakota tafter June 30, 1993, which was the date the two parties expected to finalize the trade. Further, Minnegasco stipulated it would not file a rate case with the Commission before it left the state. Therefore, the Commission's order would not be implemented in Minnegasco's rates. The Commission Staff negotiated a settlement of the appeal with Minnegasco. Under the settlement, the Commission issued an order on March 23, 1993, exempting Minnegasco from its prior PAYGO order based on the fact that Minnegasco was exiting the state. The parties the

### **MOTOR CARRIER**

## In The Matter Of The Motor Carrier Applications Of Jan Co Inc., Sioux Falls, South Dakota 23752-B, 23753-B, 23754-B, 23755-B and 23756

Jan Co, Inc., a livestock motor carrier based in Sioux Falls, applied on August 22, 1990, for five Class B livestock permits to transport livestock to and from 41 counties in South Dakota. Several existing carriers protested the permit and a hearing was held on January 9, 1991. After the hearing, the Commission issued its decision granting all five permits, as requested, by order dated March 26, 1991 (Commissioner Burg, dissenting). Several protestants applied for rehearing or reconsideration. After the oral arguments on rehearing, the Commission (Commissioner Burg, dissenting) issued an amended order on April 26, 1991. Two separate groups of protestants appealed the Commission's decision to the Sixth Circuit Court, Hughes County, by Notices of Appeal dated May 16 and 21, 1991. Protestants argued that applicant would not provide adequate service or have a presence in each of the 41 counties; that Jan Co would give a preference to the hauling of cattle for affiliates of Jan Co over other shippers; that the Commission's decision. The Commission appealed Judge Anderson's decision to the Supreme Court on November 1, 1991, and Jan Co appealed the decision on November 6, 1991. Both Appeals were consolidated by the Supreme Court on December 18, 1991. After briefing and oral argument, the Supreme Court rendered its decision on November 23, 1992. The Court denied the motion by order dated December 11, 1992.

#### <u>In The Matter Of The Motor Carrier Application Of Doyle Harms, Redfield, South Dakota,</u> 23725-B

On July 12, 1990, the Commission received an application from Doyle Harms to transport livestock to or from livestock sale barns at Redfield, Mitchell, Aberdeen, Britton, Huron, Herreid and Ft. Pierre. Harms also sought authority to haul grain between Redfield and any point in the state. Several existing motor carriers protested the permit. A hearing was held on December 13, 1990, in Pierre. The Commission issued a decision on April 19, 1991, granting the permit as requested (Commissioner Burg, dissenting). After rehearing/reconsideration, an amended decision granting the permit was issued on May 16, 1991, (Commissioner Burg, dissenting). Protestants appealed the Commission's decision to the Sixth Circuit Court, Hughes County, on May 24, 1991. Protestants claimed that the Commission's decision was clearly erroneous, arbitrary, capricious and an abuse of discretion based on the evidence in the record and that the Commission's decision was affected by error in applying applicable laws. By a decision dated September 30, 1991, Circuit Judge James W. Anderson reversed the Commission's decision. Harms appealed the Circuit Court's decision to the Supreme Court on November 25, 1991. The Commission did not appeal. The Supreme Court upheld the Circuit Court's decision by an opinion dated November 4, 1992.

#### **WAREHOUSE**

#### SOUTH DAKOTA PUBLIC UTILITIES COMMISSION V. BIRD GRAIN CO., INC. AND TRANSAMERICA INSURANCE CO., CIV. NO. 88-181\_

Bird Grain Co., Inc. (Bird Grain) operated a grain elevator in Elk Point, South Dakota. Bird Grain held a grain dealer license from the Commission, pursuant to SDCL Chapter 49-45, to buy and resell grain within South Dakota. (Transamerica) had issued Bird Grain a grain dealer bond in the amount of \$50,000 for the 1988-1989 license year. The Commission petitioned the First Circuit Court, Union County, on December 5, 1988, to appoint the Commission as the receiver stird Grain's bond proceeds, to receive the proceeds from any grain inventory and to determine the claims of producers. Barzen International, Inc. (Barzen) was licensed as a grain dealer by the Commission, pursuant to SDCL Chapter 49-45, to buy and sell grain within South Dakota. Barzen's headquarters were located at Stacy, Minnesota. During the middle of May 1990, the Commission received several complaints from South Dakota grain elevators against Grain Dealer License on May 18, 1990. The Commission issued its Order Revoking Barzen's grain dealer license on June 29, 1990. Barzen had been licensed by the Commission as a grain dealer for three years from July 1, 1987, to June 29, 1990. A license year runs from July 1 to the following June 30. Hartford Fire Insurance Company and Hartford Accident and Indemnity Company (Hartford) both issued grain dealer bonds to Barzen during the three years Barzen was licensed as a grain dealer. Pursuant to a motion by the Commission, the Sixth Circuit Court, Hughes County, appointed the Commission as the receiver to collect Barzen's bond proceeds and any traceable proceeds from grain inventory by order dated September 19, 1990. During the receivership, the Commission was unable to collect any monies other than the bond proceeds of \$25,000 for the 1989-1990 license year, which were invested in certificates of deposit. Pursuant to a published notice to submit claims, the Commission received ten claims from South Dakota grain elevators. The Commission held a claims hearing on October 26, 1990, as a referee for the Court. On December 5, 1990, the Commission filed its proposed decision with the Court and its motion to approve the decision, to direct payment of the ten claimants had valid claims in the amount of \$407,214.08.
