Pursuant to the Settlement Stipulation in Docket No. EL14-072, MidAmerican Energy Company ("MidAmerican") is required to perform quarterly reviews of its Clause ECA – Energy Cost Adjustment. Per the Stipulation, when the projected cumulative account balance divided by projected jurisdictional sales equals or exceeds ± \$0.001, a revised ECA factor will be determined and filed for implementation with the next month's billing cycle.
