Dear Ms. Van Gerpen:

Pursuant to Section No. 3, Sheet No. 33.1 (5) of NorthWestern Energy's Electric Tariff, enclosed is 316th Revised Sheet No. 33a and 99th Revised Sheet No. 33b.

Sheet Nos. 33a and 33b reflect changes in the delivered cost of fuel, delivered cost of energy and ad valorem taxes paid to be effective August 1, 2022.

The effect of Sheet Nos. 33a and 33b for a typical Rate 10 residential service customer using 750 Kwh per month would be a decrease in the monthly cost of \$4.65. The new monthly cost effective August 1, 2022 is \$101.58. Part of the reduction in cost is due to the completion of the recovery of the February 2021 cold weather event costs.
