Dear Charles,

This letter serves to summarize work to be conducted by BHE Environmental, Inc., (BHE) toward completion of tasks described in BHE proposal 06-0492, *Onsite Habitat Assessment for Protected Snakes on the Keystone Project, Missouri and Illinois*. That proposal describes assessment of potential habitat along proposed alignments of the Keystone pipeline in both states. *This letter specifically addresses only work to be completed on the Keystone Mainline in the State of Illinois*.

During remote habitat assessment of the Keystone Mainline pipeline, we identified 35 sites in Illinois that may contain habitat appropriate for the eastern massasauga (*Sistrurus catenatus catenatus*) and/or Kirtland's snake (*Clonophis kirtlandii*); both are state-listed protected species. The attached table lists the 35 sites selected for survey, and their milepost locations.

Due to site access restrictions and snow cover, field assessment was not conducted at any of the 35 sites between January 1 and March 9 2007. BHE plans to schedule a return to the sites as soon as site access is secured to all or most of the 35 sites, to complete field verification and habitat assessment as described in the study plan dated October 16, 2006 and the proposal referenced above.
