## Notice of proposed increase in electric rates

Otter Tail Power Company wants you to have as much information as possible about your electric rates so you can make wise choices regarding your energy use. On August 20, 2010, we asked the South Dakota Public Utilities Commission for permission to increase our electric rates by \$2,755,954, or about 9.96 percent, overall. This does not mean that all customers will see a 9.96 percent increase. The amount of change in each customer's monthly bill will vary based on their electric service rates and electricity use.

An average residential customer using 935 kwh of electricity a month would see an increase of \$9.68 a month over 2009. An average commercial customer using 2,415 kwh of electricity a month would see an increase of \$15.13 a month over 2009.

Otter Tail Power Company's last rate increase in South Dakota was July 1, 2009. We are requesting this increase to recover additional rate base investments (including the addition of the Luverne Wind Farm) and associated depreciation expense, Big Stone II development costs, and significant increases in operating costs incurred by our company in providing electric service to our customers. This increase is necessary as we continue to meet the growing demand for electricity and serve customers as reliably, economically, and environmentally responsibly as possible.
