MOTION FOR APPROVAL OF TRANSFER OF PERMIT

Willow Creek Wind Power LLC, successor in interest to Applicant named above and hereafter referred to as "Willow Creek", by and through its attorney, Miles F. Schumacher, of Lynn, Jackson, Shultz & Lebrun, P.C., hereby files the above referenced Motion for Approval of Transfer of Permit with the South Dakota Public Utilities Commission ("Commission"). In Support of this Motion, Willow Creek submits as follows:

1. Motion for Approval of Transfer of Permit.

This Motion is made pursuant to SDCL 49-41B-29.

The Commission granted the permit for the Willow Creek Wind Energy Facility to original Applicant, Wind Quarry Operations, LLC, on November 16, 2015, pursuant to the Stipulation entered into by Wind Quarry, LLC (parent company of Applicant), and Commission staff. On April 17, 2017, Wind Quarry, LLC changed the name of applicant from Wind Quarry Operations, LLC to Willow Creek Wind Power LLC. Pattern Renewables 2 LP acquired 100% of the membership interest in Willow Creek Wind Power LLC from Wind Quarry, LLC on May 22, 2017. Lincoln Clean Energy, LLC acquired 100% of the membership interest in Willow Creek Wind Power, LLC, from Pattern Renewables 2 LP in June of 2019. Accordingly, Willow Creek believes it is appropriate for the docket to show applicant/permit holder as Willow Creek Wind Power

conditions and modifications contained in the permit.


