With this filing, MidAmerican is proposing a number of minor “housekeeping” changes to its electric tariff. The following is a page-by-page summary of these changes.

Section No. 1, Sheet No. 5 is being revised to update the removal of the sample forms in Section 6; Residential and Commercial Applications and Deferred Payment Agreement.

Section No. 3, Sheet Nos. 2, 5, 8, 12, 14, 17, 19, 20, 23, 26, 28, 30, 31, 33, 34, 36, 38, 52, 59, 61, 62, 63, 69, 72, 75.11, 77, 81, 82, 85, 94 and 96 are being revised to provide consistency throughout MidAmerican’s electric tariff by showing text as both numerical and alphabetical where necessary.

Section No. 3, Sheet Nos. 21, 32 and 35 are being revised to change verbiage under the header GENERAL from “and applicable adjustment clauses” to “and any applicable adjustment clauses” to provide consistency throughout MidAmerican’s electric tariff.

Section No. 3, Sheet No. 24 is being revised to provide consistency throughout MidAmerican’s electric tariff by showing text as both numerical and alphabetical where necessary and to change verbiage under the header “GENERAL” from “and applicable adjustment clauses” to “and any applicable adjustment clauses” to provide consistency throughout MidAmerican’s electric tariff.

Section No. 3, Sheet Nos. 55 and 58 are being revised to provide consistency throughout MidAmerican’s electric tariff by showing text as both numerical and alphabetical where necessary and to specify the customer’s demand must be less than 200 kW so the availability requirements for Rates GET and GDT are consistent with the availability requirements of Rates GE and GD.

Section No. 3, Sheet Nos. 71, 86, 92, 93 and 95 are being revised to correct typographical errors.

Section No. 3, Sheet No. 84 is being revised to provide consistency throughout MidAmerican’s electric tariff by showing text as both numerical and alphabetical where necessary and to correct typographical errors.

Section No. 5, Sheet Nos. 9 and 25 are being revised to reflect MidAmerican’s recent customer office closures more accurately in the context of certain tariff provisions.

Section No. 5, Sheet Nos. 11 and 21 are being revised to correct typographical errors.

Section No. 5, Sheet Nos. 13, 63 and 75 are being revised to provide consistency throughout MidAmerican’s electric tariff by showing text as both numerical and alphabetical where necessary.

Section No. 5, Sheet No. 20 is being revised to provide consistency throughout MidAmerican’s electric tariff by showing text as both numerical and alphabetical where necessary and to correct typographical errors.

Section No. 5, Sheet No. 27 is being revised to update language under the “Agreements” heading to reflect current practice and procedures.

Section No. 5, Sheet No. 52 is being revised to correct the verbiage under the header “Customer-owned Equipment” from “types of meters” to “types of motors.”

Section No. 5, Sheet Nos. 85 and 86 are being revised to change verbiage under the headers “Customer- or Applicant-Requested Relocations” and “Customer- or Applicant -Requested Conversions” to provide consistency throughout MidAmerican’s electric tariff regarding when estimated costs will be trued-up to actual costs and to correct typographical errors.

Section No. 6, Sheet Nos. 1, 2 and 2.1 are being revised to reflect an updated standard residential sample bill form.

Section No. 6, Sheet Nos. 3 and 4 are being revised to remove sample forms of the residential application and commercial application. These forms are outdated, and the service application process can be conducted by electronically submitting an online request at <https://www.midamericanenergy.com/start-stop-service> or contacting MidAmerican at 888-427-5632.

Section No. 6, Sheet No. 5 is being revised to remove the sample form for establishing a deferred payment arrangement because this form is outdated, and such arrangements can be established by electronically submitting an online inquiry at <https://www.midamericanenergy.com/feedback-form> or contacting MidAmerican at 888-427-5632.

Section No. 6, Sheet Nos. 8 and 9 are being revised to reflect an updated copy of the customer release form.
