Douglas Electric Cooperative, Inc. (Douglas) has assigned territorial service rights to provide electric service to the Southeast quarter (SE1/4) of the Southeast quarter (SE1/4) of Section 36, T100N, R062W, of Washington Township in Douglas County, South Dakota.

Under the conditions of this agreement, Douglas does hereby consent that Southeastern Electric Cooperative, Inc. (Southeastern) may extend its facilities into the above-described service area of Douglas to provide electric service for a proposed seasonal service requested by Ms. Zita Bialas 27307 404th Ave, Parkston, SD 57366. Should this service change from seasonal to a residential or small commercial service, Southeastern Electric acknowledges that Douglas Electric reserves the right to provide electric service to the property.

Exhibit "A" provides the request of the owner of this land to have Southeastern serve this seasonal electric service in Section 36 described above and a township map of the general location of said service in relations to Douglas' electric distribution line and Southeastern's. This release is specifically limited to the proposed seasonal electric service and is for the life of said service.

This consent is not to be construed as having any impact upon or indicating a desire to change the service areas assigned by the South Dakota Public Utilities Commission. This agreement becomes effective upon its approval by the South Dakota Public Utilities Commission.
