Re: Errata to MidAmerican Energy Company's 2011 Reconciliation for the Electric Energy Efficiency Cost Recovery Factor. Docket No. GE12-002

Dear Ms. Van Gerpen:

On February 15, 2012, MidAmerican Energy Company (MidAmerican) filed its 2011 report and reconciliation for the 2011 Energy Efficiency Cost Recovery Factor (ECR Factor) as well as the ECR Factor to be effective from April 2, 2012 to March 31, 2013. The filing has been designated Docket No. GE12-002.

In the process of responding to a request from Commission Staff, MidAmerican discovered an inadvertent error in the sales forecast for MidAmerican's electric services in South Dakota, which impacted the calculation of the residential and non-residential ECR Factors. To correct its February 15, 2012, filing, MidAmerican submits the following errata to Exhibit C(E) page 5 of 5:

Line 1, Column (g), page 5 of 5, should read:

<u>34,000,143</u> instead of 30,790,451.

Line 2, Column (g), page 5 of 5, should read:

126,623,618 instead of 113,557,285.

The changes in Column (g), page 5 of 5, impact the ECR factors in Column (h). Column (h) should read:

Line 1, Column (h): <u>\$0.00389</u> instead of \$0.00430.

Line 2, Column (h): <u>\$0.00020</u> instead of \$0.00022.

The enclosed Revised Exhibit C(E), page 5 of 5 reflects these changes.
