SDTA Petition for Intervention

The South Dakota Telecommunications Association ("SDTA") hereby petitions the Commission for intervention in the above captioned proceeding pursuant to SDCL 1-26-17.1 and ARSD §§ 20:10:01:15.02, 20:10:01:15.03 and 20:10:01:15.05. In support hereof, SDTA states as follows:

- 1. Midcontinent Communications ("Midcontinent") has filed with the Commission an "Application for Amended Certificate of Authority" pursuant to ARSD §§ 20:10:32:03, 20:10:32:15 and 20:10:32:18, specifically, seeking authorization to provide local exchange services in the rural exchange of Wolsey, South Dakota. The Wolsey exchange is served by Santel Communications, Inc. ("Santel"), an incumbent rural telephone company that is a member of the SDTA.
- 2. SDTA is an incorporated organization representing the interests of numerous cooperative, independent and municipal telephone companies operating throughout the State of South Dakota as "rural telephone companies" as defined in 47 U.S.C. § 153(37).
- 3. A reading of the Midcontinent Application filed in this matter indicates that, presently, the company is intending to provide competitive local exchange services in the Wolsey exchange through the purchase and resale of Santel's local exchange service offerings. Reference to the resale of the services of Santel is made throughout the Application (see paragraphs 6, 9 and 11). Given this intent on the part of Midcontinent to rely on resale of the incumbent carrier services, issues of first impression with this Commission relating to the precise resale obligations of Santel, a rural telephone company, could arise. SDTA believes that any such issues, if addressed by the Commission in this proceeding, have the potential to affect the interests of other rural telephone company members of SDTA in future similar proceedings.

- 4. In addition, it is also indicated in paragraph 6 of the Application that Midcontinent is seeking a waiver of the additional service obligations imposed on competitive LECs entering rural service areas (see ARSD §§ 20:10:32:15 and 20:10:32:18). At the present time, it is SDTA's understanding that Santel has not yet determined its position with respect to the request by Midcontinent for a waiver of the established service obligations. Depending on the position taken by Santel, issues over the service obligations that should be imposed on Midcontinent as a condition of its entry into the Wolsey exchange could also be presented. Commission decisions on these issues could as well, in the future, affect other SDTA member companies.
- 5. SDTA seeks intervention in this proceeding based on the forgoing and also based on the direct interests of Santel, a present member of the Association.
