- 1 Q. Please State your name, employer, business address and telephone number.
- 2 A. My name is Tim Eklund. I am employed with TELEC Consulting Resources Inc.
- 3 (TELEC). My business address is 9300 Underwood Avenue, Suite 310, Omaha,
- 4 Nebraska, 68114. My telephone number is 402-398-0062.
- 5 Q. On whose behalf are you testifying?
- 6 A. I am testifying on behalf of Beresford Municipal Telephone Company, Kennebec
- 7- Telephone Company, McCook Cooperative Telephone Company, Midstate
- 8 Communications, Inc., Roberts County Telephone Company Cooperative
- 9 Association, and Western Telephone Company (Companies).
- 10 Q. What is your current position?
- 11 A. I am a consultant at TELEC.
- 12 Q. What are your duties and responsibilities at TELEC?
- 13 A. I am responsible for consulting with clients regarding regulatory, financial and
- interconnection issues. I am also responsible for the development of economic
- models to facilitate competitive studies and exchange/business valuations. In
- addition, I manage TELEC Consulting's cost separations team which prepares
- interstate and state jurisdictional cost studies.
- 18 Q. What is your educational and business background?
- 19 A. I received a Bachelor of Science degree with an emphasis in Accounting from
- Nebraska Wesleyan University in Lincoln, Nebraska. I joined TELEC Consulting
- in 2004, after a 23-year career with Lincoln Telephone Company, Aliant
- Communications, Inc. and ALLTEL. That prior experience included various
- 23 accounting, financial, and regulatory responsibilities.

- 1 Q. What is the purpose of your testimony?
- 2 A. The purpose of my testimony is to provide testimony on how the Companies
- 3 Intrastate Cost Studies were developed according to ARSD 20:10:27 through
- 4 ARSD 20:10:29.
- 5 Q. Did you determine the Companies' 2005 intrastate switched access rate?
- 6 A. Yes, it was determined based on the 2005 intrastate cost study with a base year of
- 7 2004 according to ARSD 20:10:27 through ARSD 20:10:29.
- 8 Q. How is the intrastate switched access rate determined?
- 9 A. It is determined by dividing the intrastate revenue requirement by intrastate
- demand.
- 11 Q. How is the intrastate revenue requirement determined?
- 12 A. It is determined by the jurisdictional allocation of regulated net investment,
- expense and taxes according to ARSD 20:10:27 through ARSD 20:10:29. The
- intrastate revenue requirement is the authorized rate of return on intrastate net
- investment plus intrastate operating expense and taxes.
- 16 O. How is intrastate demand determined?
- 17 A. A sampling of switch traffic data for the base year is captured, usually one week
- for each month. The sampling is applied to total demand to determine
- 19 jurisdictional factors (i.e interstate, intrastate, local and EAS).
- 20 Q. Were applicable SDPUC rules followed to determine the allocable portion of
- embedded costs to the intrastate jurisdiction?
- 22 A. Yes, ARSD 20:10:27 through ARSD 20:10:29 were followed to determine the
- allocation of investment, reserve, operating expense, and taxes to the intrastate

- jurisdiction. The remaining investment, reserve, operating expense and taxes
- were allocated to interstate and other in the cost study.
- 3 Q. Please summarize your direct testimony?
- 4 A. I believe the 2005 intrastate switched access rate appropriately reflects the
- 5 embedded cost of the Companies. I believe the 2005 intrastate cost study was
- developed in accordance with ARSD 20:10:27 through ARSD 20:10:29.
- 7 Q. Does this conclude your testimony?
- 8 A. Yes.
