Dear Ms. Van Gerpen:

On behalf of WWC License, LLC, I have conferred with Mr. Coit regarding SDTA's request for intervention. You may recall that WWC had raised an objection to the intervention and had asked the Commission to hear the matter during its regularly scheduled July 11, 2006, meeting.

In conversations with Mr. Coit, he has agreed that if allowed to intervene SDTA will not participate in any pre-hearing discovery, will call no witnesses at the hearing, will not cross-examine any witnesses called by Golden West, and SDTA's cross-examination of any WWC witnesses will not be redundant of Golden West's counsel's examination. If requested to by counsel for Golden West, Mr. Coit reserves the right to direct a Golden West witness with the understanding that the Golden West's counsel will then not submit additional direct on that witness.

SDTA would be able to be present at all hearings and motions and have the right to argue and brief on procedural and substantive matters that may arise in the proceeding. This includes final briefing on the record.
