**RE: REVISED SERVICE TERRITORY FOR THE CITY OF
BROOKINGS MUNICIPAL TELEPHONE, DBA., SWIFTEL COMMUNICATIONS**

Dear Ms. Van Gerpen:

Please consider this letter as an application for an amended Certificate of Authority for local exchange service pursuant to SDCL 49-31-69.

Enclosed is a Revised Franchise Service Territory Map reflecting the new telephone service territory as a result of annexation of land by the City of Brookings (See Attachment 1). Also enclosed are copies of the City of Brookings Resolutions No. 49-08 dated June 24, 2008, No. 55-08 dated July 8, 2008, No. 59-08 dated July 22, 2010 and No. 73-10 dated July 27, 2010. All resolutions are executed by the Mayor of the City of Brookings and included as Attachment 2 (1-4). The legal descriptions of Resolutions No 49-08 and No 73-10 describe the areas we wish to include in our Amended Certificate of Authority. The land annexed by Resolutions No. 55-08 and No 59-08 are areas within the City of Brookings which will not be included in our service territory. A full range of local exchange services will be provided identical to the exchange services provided to all residents of the City of Brookings.


City of Brookings Municipal Telephone, d/b/a, Swiftel Communications, is making this request pursuant to SDCL 49-31-69 through 73. We are further requesting that the Public Utilities Commission waive Rules 20:10:32:03 (1-8); (10-22);and (24).

We would further advise that in the areas annexed by Resolutions No. 49-08 and No. 73-10, are undeveloped land and there are no customers being served by either Interstate Telecommunication Cooperative or Swiftel Communications.
