On May 6, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from Metropolitan Telecommunications of South Dakota, Inc. dba MetTel (MetTel) for approval of revisions to its Competitive Access Provider Services Tariff No. 3. The purpose of this filing is to bring MetTel's tariff into compliance with the Federal Communications Commission's (FCC) Report and Order in WC Docket No. 18-156, FCC Release No. 20-143 issued October 9, 2020, regarding 8YY access charge reform.

On May 13, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of May 28, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No parties sought intervention. MetTel requests an effective date for the revisions of July 1, 2021.
