ORDER DISMISSING COMPLAINT AND CLOSING DOCKET

On October 15, 2002, the Public Utilities Commission (Commission) received a complaint filed by PrairieWave Community Telephone, Inc. f/k/a Dakota Community Telephone, Inc. and PrairieWave Telecommunications, Inc. f/k/a McLeodUSA Telecom Development, Inc. (Complainant) against Qwest Corporation (Qwest) regarding nonpayment of switched access charges and other contract disputes.

On October 17, 2002, the complaint was faxed to Qwest. Pursuant to ARSD 20:10:01:09, Qwest was notified that it must satisfy the complaint or file an answer in writing with the Commission by November 6, 2002. On November 6, 2002, the Commission received an answer from Qwest. On August 21, 2003, the Commission received a Motion to Dismiss Complaint and Request for Confidential Treatment of Exhibit B and Settlement Agreement from Complainant.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-38, 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

On September 2, 2003, at a regularly scheduled meeting, the Commission considered this matter. Based upon the Settlement Agreement between the parties and upon recommendation of Commission Staff, the Commission voted to dismiss the complaint and close the docket. It is therefore

ORDERED, that the complaint shall be dismissed and the docket closed.
