On July 20, 2005, the Public Utilities Commission (Commission) received a filing from NorthWestern Corporation d/b/a NorthWestern Energy (NWE) for approval of tariff revisions regarding a new service offering that would allow customers to lock-in their winter natural gas supply price. The service would be available to commercial and industrial customers including schools and hospitals which have requested fixed gas supply prices during the heating season. Prices would be locked in from November through April. NWE requested approval on less than 30 days notice. NWE filed the following tariff sheets for Commission approval:

ORDERED, that the request seeking approval of tariff revisions on less than 30 days notice is in the public interest and is hereby granted. It is further

ORDERED, that the above referenced tariffs sheets are approved and are effective for service rendered on and after September 1, 2005.
