On October 18, 2012, Montana-Dakota Utilities Co. (MDU) filed an Application with the South Dakota Public Utilities Commission (Commission) for approval of tariff provision to implement an Interruptible Natural Gas Transportation Service Rate 86 to be made available to customers in its East River Natural Gas System. On November 19, 2012, and December 7, 2012, MDU responded to staff's data requests, which were filed by Staff on November 20 and December 12, 2012.

On October 25, 2012, the Commission electronically transmitted notice of the filing and the intervention deadline of November 9, 2012, to interested individuals and entities. No petitions to intervene or comments were filed. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A.
