The purpose of these filings were to delete references to the 55 exchanges that have been sold by US West.

On June 27, 1996, the Commission electronically transmitted notice of the filing to interested individuals and entities. No petitions to intervene or comments were filed and a regularly scheduled July 9, 1996, meeting, the Commission considered U S WEST's request for approval of its filing.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapter 49-31, specifically under SDCL 49-31-1.1, 49-31-1.2, 49-31-4, 49-31-12, 49-31-12.2, 49-31-12.4 and 49-31-12.5. Upon review of U S WEST's filing, the Commission concludes that the proposed tariff revision is fair and reasonable and should be approved. As the Commission's final decision in this matter, it is therefore

ORDERED that U S WEST's proposed tariff revision is hereby approved as filed.
