On February 6, 1998, the South Dakota Public Utilities Commission (Commission) received a filing from the South Dakota Independent Telephone Coalition (SDITC) seeking approval of a reciprocal transport and termination agreement between CommNet Cellular, Inc. and Sanborn Telephone Company pursuant to 47 U.S.C. §§ 252(a)(1) and 252(e).

On February 12, 1998, the Commission electronically transmitted notice of this filing to interested individuals and entities. The notice stated that any person wishing to comment on the parties' request for approval had until March 5, 1998, to do so. Parties to the agreement had until March 26, 1998, to file written responses to the comments. SDITC filed its response to staff's analysis on April 14, 1998.

At its duly noticed April 22, 1998, meeting, the Commission considered whether to approve the negotiated agreement between CommNet Cellular and Sanborn. Commission Staff recommended approval.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31, and the Federal Telecommunications Act of 1996. Upon review of the agreement, the Commission found that, as required by 47 U.S.C. § 252(e)(2)(A), the agreement does not discriminate against a telecommunications carrier not a party to the agreement nor is the implementation of this agreement inconsistent with the public interest, convenience, and necessity. It is therefore

ORDERED, that pursuant to 47 U.S.C. § 252(e) the Commission approves the negotiated agreement.
