On March 26, 2012, the Public Utilities Commission (Commission) received a filing from Liberty-Bell Telecom, LLC dba DISH Network Phone & Internet (DP&I) for approval of revisions to its Access Services Tariff No. 1. This filing makes revisions to reflect the addition of language for the implementation of the intercarrier compensation regime for certain VoIP-PSTN traffic as mandated in the Federal Communications Commission's Report and Order in WC Docket No. 10-90, et al., FCC No. 11-161. DP&I also made minor amendments to its provision of switched access services and certain definitions.

On March 29, 2012, the Commission electronically transmitted notice of the filing and the intervention deadline of April 13, 2012, to interested individuals and entities. No parties sought intervention. On April 17, 2012, the Commission received responses to staff's data request and amendments to Sections 4.3.2.A and 4.3.2.C incorporating additional VoIP-PSTN clarification. On April 19, 2012, the Commission received amendments to Section 4.4 addressing retroactive billing. DP&I requested an effective date of April 27, 2012.
