On July 31, 2014, the Public Utilities Commission (Commission) received an application from Bandwidth.com CLEC, LLC (Bandwidth.com) requesting approval of revisions to its South Dakota Tariff No. 1. Bandwidth.com stated that this filing is made in compliance with the Federal Communications Commission Report and Order in WC Docket No. 10-90, et. al., FCC No. 11-161 and revises the Carrier Switched Access Service – VoIP-PSTN rates by substituting a reference to the Company's FCC access tariff for the stated rates, and also updates Bandwidth.com's corporate address on the Title Sheet. Bandwidth.com requested an effective date for this filing of August 1, 2014. On August 27, 2014, Bandwidth.com submitted revised tariff pages.

On August 14, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of August 29, 2014, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting on September 16, 2014, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. Commission Staff recommended approval. The Commission voted unanimously to approve the revisions to Bandwidth.com's Access Services Tariff Services No. 1. It is therefore

ORDERED, that the Commission approves the above-referenced pages of Bandwidth.com's Access Services Tariff No. 1 with an effective date of August 1, 2014.
