**ORDER APPROVING
TARIFF
TC13-004**

On January 10, 2013, Trans National Communications International, Inc. (Trans National) filed with the Public Utilities Commission (Commission) for approval of its South Dakota initial switched exchange access tariff, South Dakota P.U.C. Tariff No. 3. Trans National stated the Tariff sets forth the rates, terms, and conditions for the provision of intrastate switched access services provided by Trans National in South Dakota. Originating and terminating switched access rates have been set at parity with the Company's interstate rates contained in the Company's interstate access tariff, Tariff F.C.C. No. 2. Trans National stated that South Dakota P.U.C. Tariff No. 3 complies with the Federal Communications Commission's ("FCC") November 18, 2011 *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 11-161 ("USF/ICC Transformational Order") governing the Company's intrastate rate structure and Voice over Internet Protocol – Public Switched Telephone Network Traffic provisions.

On January 17, 2013, the Commission electronically transmitted notice of the filing and the intervention deadline of February 1, 2013, to interested individuals and entities. No parties sought intervention. Trans National requests an effective date of February 13, 2013.

At its regularly scheduled meeting of March 26, 2013, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL 49-31-18 and 49-31-19. The Commission voted unanimously to approve Trans National's South Dakota initial switched exchange access tariff, South Dakota P.U.C. Tariff No. 3. It is therefore

ORDERED, that the Commission approves the above referenced Trans National South Dakota initial switched exchange access tariff, South Dakota P.U.C. Tariff No. 3 effective as of February 13, 2013.
