On July 1, 2003, the Public Utilities Commission (Commission) received a complaint filed by Arnold and Steven Schurr, Roscoe, South Dakota (Complainant), against S&S Communications/Alterna-Cell (S&S) regarding loss of long distance services.

On July 1, 2003, the complaint was faxed to S&S. Pursuant to ARSD 20:10:01:09, S&S was notified that it must satisfy the complaint or file an answer in writing with the Commission by July 21, 2003. On September 2, 2003, the Commission received a letter response from S&S. On July 7, 2003, Commission Staff received a request from the Complainant to withdraw the formal complaint.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

On July 6, 2004, at a regularly scheduled meeting, the Commission considered this matter. Upon recommendation of Commission Staff, the Commission voted to dismiss the complaint and close the docket. It is therefore

ORDERED, that the complaint shall be dismissed and the docket closed.
