

# EXHIBIT A

## Legal Description of the Electric Service Territory Boundary between Kingsbury and Otter Tail

Based on a prior agreement dated the 31st day of December, 1975, signed Kingsbury Electric Cooperative, Inc. (Kingsbury) and Otter Tail Power Company (Otter Tail), the following represents the legal description of the electric service territory boundary shared between Kingsbury and Otter Tail.
