**STIPULATION AND AGREEMENT TO

As the parties seek to resolve the pending issues in this matter, it is stipulated that a continuance may be entered by the Commission to further postpone the pending filings and hearings in the matter as follows:

1. The date for completing depositions and any discovery in this matter should be continued to July 8, 2016.
2. The parties' responses to the pending cross motions for summary judgment should be continued to July 22, 2016.
3. The hearing on the pending motions for summary judgment and any other motions filed, currently tentatively scheduled for July 5, 2016, should be scheduled at a date after July 22, 2016, for a future Commission meeting.
4. The parties' exhibit lists, including copies of all of the exhibits, should be submitted to the Commission at least 7 business days in advance of the evidentiary hearing
5. The evidentiary hearing on this matter will be scheduled by agreement of the parties and the Commission at a future date.
6. The parties agree to waive the formal Notice of Hearing, as these items have already been publicly noticed in the Commission's agenda.


WHEREFORE, the parties request the Commission amend the procedural schedule as discussed above.
