We here at Hunkpati Investments are extremely excited about the new internet and technology center located in the heart of the Crow Creek reservation. This center is not only a great asset to the Crow Creek Sioux Tribe and its members but will also provide us here at Hunkpati Investments with the ability to better meet the financial educational needs of the Crow Creek Reservation.


Hunkpati Investments is a non-profit, Community Development Financial Institution organization, providing products and services to the members of the Crow Creek Reservation. Our services include providing several financial literacy classes in the interest of "promoting self-sufficiency, self-determination and an enhanced quality of life for the Crow Creek Community." Our classes include a 12 hour *Building Native Communities-Financial Skills for Families*. This course is provided at minimum once every quarter and usually scheduled during the work day on weekdays. We host an 8 hour credit builder course, *Credit When Credit is Due*. This course is offered every other month throughout the year and is scheduled on a Saturday. This course is partnered with Lutheran Social Services-Consumer Credit Counseling. We also provide a 24 hour business development course called *Indianpreneurship*. This course is scheduled at least once every quarter and held in the evenings. The latest edition to our educational courses is a 16 hour homeownership course called *Pathways Home-A Guide to Native Homeownership*. This course will be scheduled in the evenings also. Class size varies, with most averaging 6 attendees per course. Some days we will get more than 10 in the class but have rarely gone beyond 15 in attendance. With numbers like this, your facility will more than meet our current needs.

The Crow Creek Native American Telecom Internet and Technology Center will be an amazing resource for the Crow Creek Reservation. Before this center came along, there was no place for students to research their educational interests or for future entrepreneurs to research their business needs. This center will allow organizations a place to hold small classes and meetings to better serve their clientele.

We are very excited about this new center because it will provide us the ability to increase our educational services and to better meet the needs of the community. We are anxious to schedule additional options for each of the courses we offer, making them more available to our reservation members. Having this kind of access to internet ready computers will also allow us to provide more in depth training for our courses. Our business coach is excited because the entrepreneur students will be able to research more information for their business plans.

We here at Hunkpati Investments sincerely support this center and humbly thank you for your thoughtfulness and your contributions to the Crow Creek Reservation.
