COMES NOW Crystal Communications, Inc. ("Crystal") before the South Dakota Public Utilities Commission ("SDPUC") to provide notice of the adoption of the fictitious name, "Eventis." Additionally, Crystal provides the following information:

- 1) Crystal was granted a certificate of authority to provide local exchange and interexchange services by the SDPUC on August 27, 1997 in Docket TC 97-103.
- 2) Crystal is a fully-owned subsidiary of Hickory Tech Corporation, a publicly-traded holding company (NASDAQ: HTCO).
- 3) In 2000 Crystal adopted the fictitious name "HickoryTech," and has conducted business with its customers under that name since that time.
- 4) Crystal has the following affiliated telecommunications company operating in South Dakota: Heartland Telecommunications Company of Iowa and Eventis Telecom, Inc.
- 5) All Hickory Tech operating companies will now operate under the brand name "Eventis," including Crystal.
- 6) Crystal has filed the appropriate paperwork with the South Dakota Secretary of State to adopt the brand name "Eventis." (see attached Exhibit 1).
- 7) There is no change in corporate ownership or structure as a result of this assumed name change. Crystal remains a wholly-owned subsidiary of Hickory Tech Corporation.
- 8) Crystal began communicating this brand name change to the public October 7, and to its customers concurrent with October billing cycles. A copy of the customer communication is attached (Exhibit 2).
