On April 24, 2000, the Public Utilities Commission (Commission), received a complaint from Shelly Slagle, Yankton, South Dakota (Complainant) against OLS, Inc. (OLS) regarding switching telecommunications services through deceptive practices.

On April 25, 2000, the complaint was faxed to OLS. Pursuant to ARSD 20:10:01:09, OLS was notified that it must satisfy the complaint or file an answer in writing with the Commission by May 16, 2000. On May 11, 2000, the Commission received a motion to dismiss from OLS. Commission Staff received word from the Complainant stating that the complaint against OLS had been resolved.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

On August 9, 2000, at a regularly scheduled meeting, the Commission considered this matter. Upon recommendation of Commission Staff, the Commission voted to dismiss the complaint and close the docket. It is therefore

ORDERED, that the complaint shall be dismissed and the docket closed.
