On May 11, 2000, the Public Utilities Commission (Commission) received a complaint filed by Lynn and Larry Meiners, Rapid City, South Dakota (Complainants), against Minimum Rate Pricing (Minimum) regarding unauthorized switching of long distance provider.

On May 15, 2000, the complaint was faxed to Minimum. Pursuant to ARSD 20:10:01:09, the company was notified that it must satisfy the complaint or file an answer in writing with the Commission by June 5, 2000. On June 2, 2000, the Commission received a letter from Minimum.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

By order dated June 12, 2000, a hearing was scheduled for July 6, 2000, in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota, immediately following the hearing for Docket CT00-072, which is scheduled to begin at 8:30 o'clock A.M. Commission Staff was informed that settlement had been reached in this matter, so therefore the hearing is cancelled. It is therefore

ORDERED, that the hearing scheduled for July 6, 2000, is cancelled.
