On May 30, 2000, the Public Utilities Commission (Commission) received a complaint filed by Mark and Sue Cichos, Pierre, South Dakota (Complainants), against Qwest Communications, Inc. (Qwest), WebNet Com, Inc. (WebNet) and ILD Teleservices, Inc. (ILD) regarding unauthorized switching of services.

On May 30, 2000, the complaint was faxed to Qwest and WebNet. On June 2, 2000, the complaint was faxed to ILD. Pursuant to ARSD 20:10:01:09, Qwest, WebNet and ILD were notified that they must satisfy the complaint or file answers in writing with the Commission by June 19, 2000. On June 8, 2000, the Commission received a letter response from WebNet; on June 14, 2000, the Commission received an answer from Qwest; and on July 12, 2000, the Commission received a letter response from ILD.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

A hearing shall be held on August 9, 2000, beginning at 8:30 A.M., in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota. All persons testifying will be subject to cross-examination by the parties.

The issues at the hearing are: (1) whether Qwest committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate; (2) whether WebNet committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate; and (3) whether ILD committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate.

The hearing shall be an adversary proceeding conducted pursuant to SDCL Chapter 1-26. All parties have the right to be present and to be represented by an attorney. These rights and other due process rights shall be forfeited if not exercised at the hearing. If you or your representative fail to appear at the time and place set for the hearing, the Final Decision will be based solely on the testimony and evidence provided, if any, during the hearing or a Final Decision may be issued by default pursuant to SDCL

1-26-20. After the hearing, the Commission will consider all evidence and testimony that was presented at the hearing. The Commission will then enter Findings of Fact, Conclusions of Law, and a Final Decision regarding this matter. As a result of the hearing, the Commission shall determine: (1) whether Qwest committed an unlawful or unreasonable act, rate, practice, or omission and, if so, order any appropriate relief; (2) whether WebNet committed an unlawful or unreasonable act, rate, practice, or omission and, if so, order any appropriate relief; and (3) whether ILD committed an unlawful or unreasonable act, rate, practice, or omission and, if so, order any appropriate relief. The Commission's Final Decision may be appealed by the parties to the state Circuit Court and the state Supreme Court as provided by law. It is therefore

ORDERED, that a hearing shall be held at the time and place specified above on the issues of: (1) whether Qwest committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate; (2) whether WebNet committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate; and (3) whether ILD committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate
