On December 6, 2000, the Public Utilities Commission (Commission) received a complaint filed by Mike Mattern, Aberdeen, South Dakota (Complainant), against McLeodUSA Telecommunications Services, Inc. (McLeod) regarding poor service

On December 6, 2000, the complaint was faxed to McLeod. Pursuant to ARSD 20:10:01:09, McLeod was notified that it must satisfy the complaint or file an answer in writing with the Commission by December 26, 2000. On December 22, 2000, the Commission received an answer and motion to dismiss from McLeod. On January 9, 2001, the Commission received a letter from Complainant requesting that Qwest Corporation (Qwest) be added to his complaint.

On January 17, 2001, at a regularly scheduled meeting, the Commission considered this request. The Complainant stated he did not have a problem with Qwest, he just wanted some information from Qwest. Qwest's representative stated Qwest would provide the information through a subpoena. The Commission voted to deny the request to add Qwest as a party (Pam Nelson, dissenting). On April 19, 2001, McLeod filed a Motion to Join Qwest as a Party. On April 24, 2001, Qwest filed its Response to Motion of McLeodUSA to Add Qwest as a Party. On May 8, 2001, at a regularly scheduled meeting, the Commission considered this matter. Qwest did not object to being added as a party. The Commission voted to grant McLeod's Motion to Join Qwest as a Party.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

A hearing shall be held on June 20, 2001, beginning at 2:00 P.M., in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota. All persons testifying will be subject to cross-examination by the parties.

The issue at the hearing is whether McLeod and/or Qwest committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate.

The hearing shall be an adversary proceeding conducted pursuant to SDCL Chapter 1-26. All parties have the right to be present and to be represented by an attorney. These rights and other due process rights shall be forfeited if not exercised at the hearing. If you or your representative fail to appear at the time and place set for the hearing, the Final Decision will be based solely on the testimony and evidence provided, if any, during the hearing or a Final Decision may be issued by default pursuant to SDCL 1-26-20. After the hearing, the Commission will consider all evidence and testimony that was presented at the hearing. The Commission will then enter Findings of Fact, Conclusions of Law, and a Final Decision regarding this matter. As a result of the hearing, the Commission shall determine whether McLeod and/or Qwest committed an unlawful or unreasonable act, rate, practice, or omission and, if so, order any appropriate relief. The Commission's Final Decision may be appealed by the parties to the state Circuit Court and the state Supreme Court as provided by law. It is therefore

ORDERED, that a hearing shall be held at the time and place specified above on the issue of whether McLeod and/or Qwest committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate.
