On July 23, 2007, the Public Utilities Commission (Commission) received an application from MidAmerican Energy Company (MidAmerican) requesting approval to extend the existing Monthly Metered Transportation Gas Pilot Project and the Interruptible Monthly Metered Transportation Gas Pilot Project through April 30, 2008. These gas pilot projects are set to expire August 31, 2007. The Iowa Utilities Board is currently reviewing the results of similar programs that are set to expire April 30, 2008, in Iowa and MidAmerican is requesting that the South Dakota programs expire at that time also, so changes, if any, can be filed concurrently in both jurisdictions. The revised tariff sheets are as follows:

At its regularly scheduled meeting of August 28, 2007, the Commission discussed final approval of the application. Commission Staff recommended approval of the tariff revisions.



ORDERED, that the above-referenced revised tariffs are approved, with an effective date of September 1, 2007.


