**ORDER APPROVING TARIFF
REVISIONS**

On April 6, 2012, Sancom, Inc., dba Mitchell Telecom (Sancom) filed an application with the Public Utilities Commission (Commission) for approval of revisions to its Intrastate Switched Access Tariff No. 1. In this filing, Sancom is including exceptions to the approved revisions to Local Exchange Carriers Association's (LECA) South Dakota Access Tariff No. 1 (LECA Tariff). The LECA Tariff was recently revised to be in compliance with the Federal Communication Commission (FCC) Report and Order in WC Docket Nos. 10-90, FCC Release No. 11-161 (Nov. 18, 2011). These approved revisions have an effective date of December 29, 2011. Further, this filing was made pursuant to the FCC Clarification Order issued February 3, 2012 (DA 12-147). In this Order, at the end of paragraph 24, the FCC clarified "when a carrier's intrastate access rate is lower than its corresponding interstate access rate, that carrier may not, in its intrastate tariff, include a rate for toll VoIP-PSTN traffic that is higher than its intrastate access rate." Sancom has a lower intrastate switched access rate per minute on the intrastate jurisdiction versus the interstate jurisdiction.

On April 12, 2012, the Commission electronically transmitted notice of the filing and the intervention deadline of April 27, 2012, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of May 8, 2012, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. The Commission voted unanimously to approve the requested revisions to Sancom's Intrastate Access Services Tariff No. 1. It is therefore

ORDERED, that the Commission approves the above referenced revisions to Sancom's Intrastate Access Services Tariff No. 1 effective as of December 29, 2011.
