On July 3, 2012, the Public Utilities Commission (Commission) received a filing from AT&T Communications of the Midwest, Inc. (AT&T) for approval of revisions to its Access Services and Network Interconnection Services Tariff. The purpose of this filing is to modify tariff language for the Identification and Rating of VoIP-PSTN Traffic to be in compliance with the Federal Communications Commission's Connect America Fund et al., WC Docket No. 10-90 et al., Second Order on Reconsideration, FCC 12-47 (rel. April 25, 2012). In the order, the FCC permitted local exchange carriers to tariff default charges equal to intrastate originating access for originating intrastate toll VoIP traffic until June 30, 2014.
