On April 10, 2014, the South Dakota Public Utilities Commission (Commission) received a filing from Teleport Communications America, LLC (TCAL) requesting approval of revisions to its Access Services Tariff. With this filing, TCAL proposes to introduce Public Switched Telephone Network (PSTN) Interconnect Service and edit language in its Access Services Tariff.

On April 17, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of May 2, 2014, to interested individuals and entities. No parties sought intervention. On May 15, 2014, TCAL responded to Commission staff's data request.
