**ORDER APPROVING

On June 3, 2014, the South Dakota Public Utilities Commission (Commission) received a filing from TNCI Operating Company LLC (TNCI OpCo) requesting approval of its revisions to its South Dakota switched access tariff. This submission is made pursuant to the Federal Communications Commission's (FCC) Report and Order and Further Notice of Proposed Rulemaking, in Docket Nos. WC Docket No. 10-90, et al., FCC 11-161 Second Order on Reconsideration in Docket No. WC Docket No. 10-90, et al., FCC 12-47 and Section 51.911 of the FCC's rules, 47 C.F.R. § 51.911. A July 1, 2014, effective date is requested.

On June 5, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of June 20, 2014, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of June 24, 2014, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. The Commission voted unanimously to approve the requested revisions to TNCI OpCo's Switched Access Tariff with an effective date of July 1, 2014, provided that TNCI OpCo file an updated tariff sheet correcting first revised sheet no. 41. It is therefore

ORDERED, that the above-referenced revisions to TNCI OpCo's Switched Access Tariff are hereby approved and effective as of July 1, 2014.
