TARIFF REVISIONS

On June 24, 2015, the South Dakota Public Utilities Commission (Commission) received a filing from Interstate Telecommunications Cooperative, Inc. (operating in Milbank, South Dakota) (ITC CLEC) requesting approval of revisions to its South Dakota Access Service Tariff No. 1. ITC CLEC is submitting this filing to be in compliance with the Federal Communications Commission's November 11, 2011, Intercarrier Compensation Reform Order (FCC 11-161). ITC CLEC requests that the tariff revisions become effective on July 1, 2015. On July 1, 2015, and July 7, 2015, ITC CLEC submitted new tariff pages.

On June 25, 2015, the Commission electronically transmitted notice of the filing and the intervention deadline of July 10, 2015, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of July 21, 2015, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31.
