On July 31, 2015, the South Dakota Public Utilities Commission (Commission) received a filing from MCC Telephony of the Midwest, LLC (MCC Telephony) requesting approval of revisions to its Access Services Tariff No. 1. The purposes of this filing are to maintain MCC Telephony's switched access rates at applicable benchmark levels, incorporate cross-references to its federal tariff for terminating rates, and insert clarifying text. MCC Telephony requests an effective date of August 30, 2015. On October 29, 2015, MCC Telephony responded to Staff's data requests.

On August 6, 2015, the Commission electronically transmitted notice of the filing and the intervention deadline of August 21, 2015, to interested individuals and entities. No parties sought intervention.
